Sri P K Singh Rathor informed the house that there was a meeting of AIACE with the Secretary of Deptt of Public Enterprises and Joint Secretary,Ministry of Coal on 28 June,2019 over various issues of working and retired Executives of Coal India and Singreni Coal Company.He further told that Sri Abdul Kalam,Ex CMD,Sri Ramesh Kumar,Ex Director and Sri P K Singh Rathor represented from AIACE side.The meeting was fruitful and we were assured that necessary action will be taken at respective levels.

Sri P K Singh Rathor welcomed all members and hoped that with their active cooperation , our association is serving well.

Later on agendawise discussion was held as below.

1.Pay revision Wef 1/1/2017 and pay anomaly -- Sri P K Singh Rathor told that with DPE,Secretary the issue of pay revision was raised forcefully and it was aprised that due to this revision,the Executives have been put into disadvantage as the salary of staffs has been fixed higher in comparison to E1 and E2 level Executives.Due to this ,there is a huge resentment among Executives and particularly in young executives.We also raised the issue for restoration of Coalfield allowance and LTC/LLTC alongwith pay revision on line of Maharatna company.

The Secretary ,DPE told that the pay revision in PSUs has been implemented after cabinet approval and DPE is not in position to approve any change.It was also told that ciculars were issued before finalisation of pay revision of workers that care should be

taken so that workers salary does not come in conflict with Executives salary. But CIL did not take it seriously and due to this problem has arisen.

AIACE representatives insisted on doing something to resolve the conflict.

2 Career growth -- Sri P K Singh Rathor told that issue of career growth was also discussed with Joint Secretary (Coal) and particularly stagnation in E6 grade. It was informed that necessary instruction would be issued to Coal India by the ministry. Sri Rathor also informed that after meeting there in Delhi, things started moving regarding promotion and huge promotion order has been issued in mining discipline from E6 to E7. He also informed that the work on promotion in non-mining discipline is underway.

3. Perks and allowances-- AIACE also raised issue for restoration of Coalfield allowance and LTC/LLTC and management is being approached for it.

4 .Enhancement of pension under CMPS 1998-- The enhancement of pension is the burning issue as of date. Sri Rathor informed that we are continuously working for it. But the sub-committee constituted by CMPFO has recommended for ceiling of pension at RS 45000/month which is not at all acceptable to us. He told that we will intensify the struggle soon and we may go for demonstration in Delhi in coming November for pressing our demand.

5 NPS-- It was informed that issue has almost been resolved and balance cases are being taken up with management. We are now pressing hard for giving interest on NPS fund.

6 .CPRMSE-- Members showed concern over poor implementation of CPRMSE and denial of cashless facility by empanelled hospitals. It was decided to take up the issue at CIL and subsidiary level.

7. Payment of PRP for 2017-18 and 2016-17 (Jan-March 2017)-- Sri Rathor informed that we were waiting for completion of NPS issue and almost it is over. Now we will take up PRP issue.

8 Proposed medical camp and health talk in Sept, 2019-- It was decided to organise a health talk in the month of September in Bilaspur

9. Purchase of magazine AIACE Today-- Members were informed about printing cost of the magazine. All members agreed to purchase the magazine after printing. Sri V K Mahaldar, Sri A Adhikari and others deposited RS 500/each for purchasing it.

ALL INDIA ASSOCIATION OF COAL EXECUTIVES (AIACE)**MINUTES OF MEETING OF AIACE HELD ON 27.9.2019 HELD****AT QUTUB GOLF COURSE, LADO SARAI, NEW DELHI.**

All India association of Coal Executives (AIACE) organised its meeting on 27/9/2019 in the Conference Room of Qutub Golf Course at Lado Sarai, New Delhi under the chairmanship of Sri R. B. Mathur, ex-CMD. Sr A. Kalam, ex-CMD and President of Delhi NCR Branch welcomed all the participants and conducted the proceedings successfully.

First of all, members were apprised about today's presentation of our emagazine AIACE Today to Sri Rakesh Choudhary, Addl. Secy, DPE. The team led by Sri Abdul Kalam accompanied by Dr B K Shrivastav, Sri Rameshwar Ojha and Sri T D Vishwakarma handed over print version of the magazine to him. The team had a fruitful interaction with Addl. Secy, DPE.

The following issues were discussed.

1. Enhancement of pension under CMPS 1998--

It was felt that efforts are to be enhanced for revision of Pension by linking it with DA.

It was resolved that fight must go on for same grade ,same pension.

For staging one day dharna in Delhi for attracting attention of the govt ,Sri P K Singh Rathor, Convenor, AIACE/AICPA was authorized to fix a date in consultation with other associations which are also fighting for enhancement of pension. It was opined to organise dharna in the month of December and in the meanwhile all efforts should be made to apprise coal minister regarding plight of old coal pensioners.

2. CPRMSE--

It was emphasized that efforts are to be made for compelling the management to allow treatment in all hospitals, irrespective of empanelment and cost of reimbursement be made admissible as per CGHS rules. Further it was desired that modalities may be found out for revision of these CGHS rates which are quite old leading to refusal of treatment by leading hospitals at these rates. It was highlighted that on this very ground

of low CGHS rates, leading hospitals are even denying admission of patients stating non-availability of bed, whereas, beds are found to be available otherwise.

It was informed by members that Max Hospital, Saket is not extending treatment to CIL employees as per panel rates and the members requested to bring this fact to notice of CIL management. It was also pointed out by members that CPRMSE provides for seeking prior approval in certain type of emergent treatment and the approving authority is not always available due to holidays or otherwise. It was desired that management can be persuaded to nominate second-in-command approving authorities so that necessary approval can be obtained without any hindrance.

The move to enhance the CPRMSE annual reimbursement from Rs 15000 to Rs 36000 was welcomed by all members present. However all of them opined that this enhancement is too little and too late considering the state of affairs in other Maharatna companies. Members desired that this may be discussed with Chairman, CIL.

3.NPS -- Regarding implementation of NPS, it was informed that it is not 100% full of satisfaction of executives. There are several problems, and many members are still awaiting their turn for payment. It was informed that central body of AIACE is very active in this regard and cases are being regularized slowly, but, steadily. The present status on payment of Interest on NPS corpus fund was also discussed.

4. Liaisoning with coal ministry--

Members expressed to offer their services for liaisoning with ministry officials, if required.

With the new government in power at centre along with of many changes in the top level hierarchy at ministry and likely changes at CIL, it was suggested to fix a meeting with Coal Minister and other officials for finding ways to find out forceful solution to our aspirations and demands.

5. Purchase of magazine--

For purchase of hard copy of inaugural issue of AIACE Today, members were, in general, willing to purchase it and it was suggested that a letter to the effect may be written by Convener to respective Branches and willing members can express their consent to respective branches. Members were more interested to go for buying photo-gallery section of the magazine and desired that prices may be further reduced to Rs 300 for which necessary curtailment in contents could be explored.

6. Help Line--

The meeting further resolved to start a Helpline platform for Delhi-NCR members so that members in need OR emergencies can avail timely assistance. It was suggested to turn the present Whatsapp GROUP of Delhi-NCR to act as such a helpline. Members desired to request the Convener to nominate few more ADMINS for this group. For this purpose, name of Sri Kalam was suggested to be made as Admin, who, in turn, will further nominate a few more active members of Delhi-NCR region to act as Admins.

कोल माइंस पेंशनर एसोसिएशन एचएमएस की महत्वपूर्ण बैठक

बैतूल। कोल माइंस पेंशनर एसोसिएशन एचएमएस की महत्वपूर्ण बैठक रविवार को शहीद भवन में आयोजित की गई। बैठक की अध्यक्षता संघ के अध्यक्ष बीएल सोनी ने की व कोल माइंस पेंशनर की बैठक में डीए तथा रिवीजन के प्रावधान की जानकारी दी।

इस दौरान संघ के संरक्षक दिनकर साहू ने कोयला खान भविष्य निधि आयुक्त कार्यालय नई दिल्ली धनबाद से प्राप्त पत्र में उल्लेखित डीए तथा रिवीजन के प्रावधान के बारे में कोलमाइंस पेंशनरों को जानकारी दी। उन्होंने बताया कि बोर्ड ऑफ ट्रस्टी की बैठक में पेंशन रिवीजन, डीए, पेंशन बढ़ोतरी तथा बीमारी भत्ता स्वीकार करते हुए अनुमोदन के लिए भारत सरकार को प्रेषित किया जाना है। महामंत्री डीआर झरबड़े ने बताया कि पेंशनरों की विभिन्न मांगों को लेकर जंतर-मंतर दिल्ली में माह नवंबर में धरना प्रदर्शन किया जाएगा। इसमें सभी पेंशनधारियों को भाग लेना है। संघ के जिलाध्यक्ष बीएल सोनी ने बताया कि धरना प्रदर्शन के विषय पर राष्ट्रीय कोल पेंशनर एसोसिएशन के अध्यक्ष पीके सिंह राठौर से हुई चर्चा के अनुसार उन्होंने बैतूल जिले से लगभग 500 सदस्य दिल्ली पहुंचने की बात की है, इसके लिए उन्होंने व्यापक प्रचार-प्रसार करने की बात कही। उन्होंने बताया कि अधिकांश कोल पेंशनरों को 150 से 1000 प्रति माह पेंशन प्राप्त हो रही है जो बेहद शर्मसार है। इस संबंध में उन्होंने कोल इंडिया के पांचों संगठनों के नेताओं से हड़ताल के मुद्दों में एक बिंदु पेंशन को भी शामिल करने की अपील की है। गौरतलब है कि 30 से 35 साल की सेवा देने के बाद भी ऐसे पेंशनरों की हालत बहुत ही दुखद है। वर्तमान में ऐसे पेंशनर गंभीर बीमारी एवं लाचार जिंदगी जीने के लिए मजबूर हैं। बैठक में इन मुद्दों पर भी विचार किया गया। बैठक में प्रमुख रूप से संरक्षक दिनकर साहू, अध्यक्ष बीएल सोनी, महामंत्री डीआर झरबड़े, रूपलाल मानेकर, लीलाराम विश्वकर्मा, डीडी लोखंडे, हेमराज धोटे, पांडुरंग वरवड़े, मानिकराव कापसे, बिहारीलाल सोनी, आरडी सोनी, भूरा दीघेकर, पूरनलाल मालवीय, भोजराव वाग्द्रे, नागोराव वाग्द्रे, नारायण मिश्रा, रमेश बेले, चंद्रकिशोर लिलहोरे, सीतोबा सातनकर, इसरार अहमद सहित सैकड़ों सदस्य उपस्थित रहे।
