Sub: Request for providing Authority commensurate with responsibility to Executives at every level (grade) of Organizational structure

Dear Sir,

CIL is a very big organization employing manpower at workmen, supervisory and executive levels. It is imperative that an executive cannot perform his duty without proper authority. The delegation of authority to an executive at his/her level makes him/her responsible and accountable for accomplishing organizational goals.

Sadly, in CIL, most of the executives are made responsible and accountable for their doings without defining Authority and powers associated with a particular post. The "Role Profile of unique positions in CIL and Subsidiaries" published by Policy cell of CIL is also silent on this aspect. This book has defined Roles, not for all, but for a selective level of executives. Even this book is not well circulated and most executives are unaware of its contents.

So, a time has come when there emerges a need to clearly specify the Authority and Powers associated with every level of executives in CIL. This will make executives fulfil their tasks with ease and overall performance of CIL is bound to improve. In the present scenario, even if an executive is promoted to next higher grade, he/she continues to work in the same fashion commensurate with the level of his/her previous grade. Also, executives are unaware of expectation of management from him/her. It has been seen that lower level executive of some disciplines enjoy more authority than many senior level executives of other disciplines. This causes interdisciplinary rift and also has bearing on overall efficiency of the organisation.

In the light of above facts, our Association proposes that authority must be delegated to each Executive at his/her level irrespective of discipline he belongs to so that he /she does not feel difficulty in discharging his duty. With Regards,

Sub: Resubmission of earlier requests for accepting Jeevanpramaan as DLC under CPRMSE and CPRMSNE

Dear Sir,

Submission of Life certificate, by retired employees, is an essential requirement for continuation of Pension(s) from CMPF and CIL sponsored EDCPRPS as well as Post retirement Medical benefits.

While the Pension scheme by CMPF has transformed itself to accept digital submission in the form of JeevanPramaan, the annuity providers under CIL sponsored EDCPRPS, have also devised their own ways of online submission of Life certificates, (LC).

It is a pity that a Maharatna organization like Coal India has not still devised any digital/online mode of submission of LC and depend on old cumbersome methods for LC. In this regard, we are yet to know the response on this issue from your end to our various letters written vide nos. AIACE/CENTRAL/01dated 06-01-2020, AIACE/CENTRAL/037 dated 25-04-2020, AIACE/CENTRAL/043 dated 07-05-2020, and AIACE/CENTRAL/093 dated 11-09-2020.

Further to our above letters requesting you to accept Digital Life Certificate-Jeevanpramaan- under CPRMSE, we once again appeal to you to consider acceptance of Jeevan Pramaan as Life Certificate for the purpose of CPRMSE and CPRMS-NE. Pensioners are already generating Jeevan Pramaan for the purpose of Pension under CMPS, 1998 and it would be a simple matter to submit, by ordinary post/e-mail, this certificate along with details of Medical Card and EIS Number. It is seen that Coal India Ltd. is on board JeevanPramaan as a sanctioning & disbursing authority and need not have any reservations about its acceptance. Jeevan Pramaan, digitally verified with Aadhar biometrics is the most authentic life certificate and its acceptance would relieve the vast number of pensioners the trouble of getting multiple life certificates under different schemes. In this age of digitisation, this should be the norm rather than the exception.

We earnestly request you once again to issue instructions to accept JeevanPramaan under CPRMSE and CPRMS-NE and clearly identify the contact details of the authority to whom life certificate is to be emailed.

Sub: Release of pending bills of retired executives submitted for reimbursement under CPRMSE Dear Sir,

It is to inform you that, various reimbursement claims submitted by retirees under CPRMSE benefits are held up at BCCL. The bills are not being processed by respective authorities and cases have multiplied specially after outbreak of Covid-19 and imposition of lockdown.

You will agree, Sir, that the retirees are financially overburdened people and are in urgent need of money blocked in their various claims. These retirees are doubly hit as first of all empanelled hospitals of CIL are denying them the cashless facility, followed by non-reimbursement of claims when they pay it of their own pockets. Even half-yearly claim of Rs 18000/- has not been paid to many executives. The pain is greater when they find regular payments to their colleagues in other subsidiaries.

We appreciate your constraints for lack of funds, but at the same time it is expected that the management also appreciate the misery of these retirees. Corporate finances may be settled sooner or later, but the individual suffering of executives cannot wait for these settlements as healthcare is of primary importance to them who are mostly at the fag end of their life living in fragile health conditions.

Hence, it is requested to kindly advise concerned departments for arranging a little fund from available resources and expedite the payment to ease financial hardship being faced by retirees. Even CIL may be approached for separate funds as CPRMSE is centrally controlled, managed and funded by CIL.

Sub: Implementation of amendments in PMS Manual with retrospective effect

Dear Sir,

Coal India Ltd. has issued a circular no. CIL/C5A (PC)/PMS/469 dated: 13.08.2020, whereby, it has done some amendments in Performance Management System (PMS) Manual with immediate effects.

These amendments have laid out various provisions related to generation of PRIDE form of an executive and the Role & Responsibility of authorities have been defined. Further, a new provision has been added too, whereby, in the event of non-submission of self-appraisal by an Executive, the concerned Reporting Authority (RA) will initiate the PRIDE form and rate the Executive for that particular period. On completion of the scheduled timeline, the initiated PRIDE form will be automatically moved to higher authorities for further appraisal alike normal PRIDE forms.

This new provision will mostly help the executives who are on the verge of retirement OR are transferred to a new place of posting as they are unable to generate their PRIDE forms timely in the existing Performance Management System.

This provision is a welcome addition and going to help a lot to the present executives on roll of CIL.

We request that, this provision be made effective with retrospective effect since the implementation date of PMS in CIL. This will greatly benefit the executives who have retired in the past without being able to submit their PRIDE form for PMS due to non-availability of clear-cut directives. This situation has deprived them of PRP payment which is naturally a part of their salary.

Under the circumstances, it is requested to kindly issue directive for retrospective implementation of this amended PMS Manual which will amicably settle many pending PRP payment cases.

It is fact that in the age of digitisation and central govt emphasis on paperless work, widows are required to travel to the units from where their husbands retired for completing the formalities for start of pension after death of the pensions in the old age .

It seems, we have failed to impress you with the various facts stated in these letters.

We seek an appointment with you at the earliest, for a one-to-one mutual discussion to understand each other's problem and constraints in order to work together to find an amicable solution.

The meeting will revolve around to work out an amendment in rules so that, in spite of Pension Account being made "Former or Survivor" by an earlier order from CMPFO, a widow/widower settled in remote locations of our nation are required to come over all the way to the place of retirement.

We sincerely hope granting of time at the earliest, for a meeting with you, in which 2-3 members of AIACE will visit your office and appraise the ground level situation.

The Submission of Life certificate, by retired employees, is an essential requirement for continuation of Pension(s) from CMPF to coal pensioners. Thousands of these pensioners, exemployees of Coal India and SCCL are settled in proximity to coalfields across the country. Every year, these coal pensioners exert a lot to obtain and submit Life Certificates to Banks in order that their pensions continue uninterrupted.

Fortunately, CMPFO has boarded online digital platform Jeevanpramaan which facilitate online generation and submission of Life Certificate(s). This method is in its nascent stage is yet to be fully realised and utilised by pensioners.

AIACE is happy to announce that it has made a tie-up with India Post Payment bank (started by Post and Telegraph Deptt, Govt of India) for generation and submission of digital life certificate of coal pensioners to CMPFO for continuation of pension. In this method the pensioner has to bear a cost of Rs 70 per head. (Operative part copy of our MOU enclosed).

Simultaneously, AIACE has also procured Biometric Devices at various locations in India and offering this service for Life Certificate free of cost.

We understand that at all the Subsidiaries level and even at CIL level, special cells are operative for assisting retired employees (executives and non-executives both) of CIL and SCCL. AIACE is willing to offer its assistance to these cells for so that retired employees at Area-level and Subsidiary-level are able to generate and submit Life Certificate(s) in a hassle free way. AIACE wishes to organise DLC generation camp at different places. All pensioners will be greatly benefitted by these camps which we propose in collaboration with India Post Payment bank.

The DLC generated may also be used for continuation of CPRMSE/CPRMSNE benefits to retired coal employees.

We hope, you will consider our proposal with a clear understanding and appropriate actions from your end will be initiated in the quickest possible time.

It is requested to issue necessary instruction to all concerned to facilitate space for organising such camps at different places in Coalfields to help the pensioners. Regards,



The broad flow of the DLC generation through IPPB is as below:

- Pensioner requests for a doorstep service of DLC or visits the nearest post office
- The postman/Grameen Dak Sevak accesses the completely digital interface from his/her mobile and assists the pensioner to generate the DLC. Important prerequisite to the process is the registration of aadhaar number of the pensioners with the Pension Disbursing agency.
- The pensioner provides details like aadhaar number/VID, PPO number, Pension Sanctioning authority, disbursing agency details, etc required in the application through the postman and further verifics through Aadhaar based biometrics.
- The Jeevan Pramaan ID is generated based on the valid inputs provided by the pensioner and updated directly to the pension disbursing agency.

Further, IPPB would also like to introduce the below listed services for the pensioners and staffs of CMPFO that can also be availed through the postman or the nearest post office:

- Aadhar ATM/Any Bank ATM (Aadhar Enabled Payment Services) The pensioners and staff of CMPFO would be able to withdraw their money from the respective Aadhar linked bank account through biometric authentication.
- **IPPB Savings Account** IPPB offers Simplified Account opening process using Aadhaar and mobile number for a Zero balance savings account.

Dear Sir,

For executives working in CIL, a trust was formed to implement the provision of pay revision of executives of CIL with effect from 01-01-2007. This Trust was entrusted with the task of creating and managing a Pension Fund for its executive cadre employees. As per clauses of pay revision, executives were awarded a third benefit of additional contributory Pension for which on behalf of executives, CIL contributed benefits @ 9.84% of Basic pay and Dearness Allowance is to the pension fund. It took almost 2 years to implement the pay revision, and another 10 years to create the Trust. For all these 10 years, CIL kept the fund in its account. The Trust Deed has envisaged in writing that the accrued interest will be transferred to beneficiaries, but, the BOT of Trust failed to act apparently due to indecision at the concerned level. While other PSUs have already disbursed the interest portion, the Trustees and Coal India Ltd both still awaits directives from central government.

To explain the case and for understanding the constraints and present status, we seek a one-to-one appointment with you in the nearest future at a date most convenient to you.

Finally it may be emphasized that, AIACE is a duly registered body under the Trade Union Act, 1926.

Sub: Request for Various Amendments in CPRMSE and inclusion of Divyang children as beneficiary

Dear Sir,

Coal India Ltd. has implemented a Contributory Post Retirement Medicare Scheme called CPRMSE for retired executives. Under this schemes, CIL and its subsidiaries are extending medical facilities to the retired employees and/or their spouses in CIL Hospitals along with 344 empanelled hospitals across India where employees prefer to stay after retirement.

This scheme presents a very rosy picture at the first glance, but after 8 years of implementation, retirees are now realising the dark side of this scheme as they are now unable to avail hassle free treatment for themselves and their dependents. No doubt, CIL is a Maharatna company but its beneficiaries are losers in every respect.

This time we have following 3 areas which require your immediate attention.

(i) Cashless Treatment at empanelled hospitals

Almost all hospitals refuse cashless treatment, do not extend CGHS rates for treatment and due payments/re-imbursement to willing hospitals and executives are delayed abnormally. During our interaction at CIL, HQ in February, 2020 we were given to understand that things will improve soon citing the ongoing work of Smart cards for CPRMSE beneficiaries. However, over the past several months, we are forced to conclude that these Smart Cards will only show online Balance of Executives Beneficiary Amount and won't serve any purpose. Otherwise, the entire bill settlement and 24x7 cashless treatments will remain in our dreams only. Our earlier proposal of engaging Bill Processing Agency was also not found acceptable at your end.

After all we cannot blame CIL also for this failure because, the core business of CIL remains coal production and it cannot undertake the tedious job of running a Medicare scheme for the manpower which is not on its roll. So we have now developed a mid-way solution to problem as briefed below.

CPRMSE is conceived to be managed by a Trust to provide the retirees with medical benefits which are both Indoor (IPD) and Outdoor (OPD). Generally, most executives avail OPD treatments and delays in cashless treatment/payment/reimbursement can await improvements in the system by CIL. On the contrary, IPD treatments are few in numbers but are critical in nature requiring immediate cashless treatment and needful competent approval. We suggest that OPD treatments can be retained by CIL and the IPD treatment part may be off-loaded to Health Insurance companies. Of course, engaging Insurance companies will require payment of Annual premiums for which a suitable mechanism for sharing premium may be evolved in consultation with Insurance companies and retirees in general. Now a days, Insurance companies are offering Individual Floater premium for Senior Citizens for a minimum coverage of Rs 10 lakhs to maximum of Rs 25 lakhs. If CIL ropes in Companies for Group Health Insurance schemes, the competitive lower premiums can be ensured. Proceeding further, if CPRMSE Trust is unable to bear this premium even by suitably adjusting yearly OPD payments (which at present is limited to Rs 36000 only), contributions from members may be invited. Many PSUs including SAIL etc. have opted for Insurance based post-retirement medicare for their employees.

(ii) Eligibility of Divyang children to be allowed under CPRMSE

Secondly, the post retirement medical scheme for non-executives, CPRMSNE, has a very useful criteria of eligibility for beneficiaries. Under Section 2.0, it has allowed Divyang Child(ren), without age limits, to be beneficiaries. We also request similar inclusion in CPRMSE by issuing suitable amendment order.

We have received representation from some of our members that benefits of CPRMSE may please be extended to their dependent Divyang children who are not presently covered. There are also some cases of dependent children suffering from critical illnesses such as kidney failure, heart disease, etc. List of such Divyang cases is enclosed in Annexure.

You will appreciate that parents are dependent on their children in their old age, but when they have to look after disabled children it becomes both financially and psychologically very hard on them.

We earnestly appeal to you to extend coverage of CPRMSE to dependent Divyang and critically ill children of retired executives of Coal India Ltd. Decision on this matter may please be taken at the earliest as many of the retired executives are in the evening of their lives and hope that such children are properly cared for.

(iii) Revision to allow treatment in NABH Hospitals and Laboratories

Last, but not the least, we once again reiterate our request to approve treatment at all hospitals and laboratories which are approved by National Accreditation Board for Hospitals & Healthcare Providers (NABH), many of whom are charging at affordable rates. This will end dependence on and monopoly of empanelled hospitals and benefit all executives, who are settled across the length and breadth of country; and also it will benefit the executives to avail facilities at their neighbourhood.

In the past, we have written several letters seeking improvement and amendments in CPRMSE but all have gone into deaf ears. It is a pity that, while in power, the decision makers are not taking corrective measures and a time comes when they too become a victim of their failures.

However, this time we firmly believe that the above suggested reforms will go a long way to help the retirees approaching at the fag end of their lives.

Sub: Protest against decision to Freeze DA of executives working in CIL in the name of Covid-19

Dear Sir,

Kindly recall your directive issued to all PSUs for announced freezing of additional dearness allowance for executives and non-unionised supervisors of central public sector enterprises (CPSEs) drawing salaries under certain pay scales till June 30, 2021. Vide OM No. W-02/0038/2017-DPE (WC)-GL-XVI/20 dt. 19th November, 2020. This order has impacted in CIL also in which executives have exerted extra efforts during the Covid-19 pandemic to meet the energy demand of the country. Your attention is requested to be drawn to the fact that, even as the country's core sector output contraction has narrowed sharply to 0.8 per cent in September 2020, growth in the coal sector was 21.2 per cent, the highest among all the eight core sector industries, compared to the same month last year.

The trend has continued and CIL produced 46.8 million tonnes (MT) of coal in the month of October 2020, against 39.5 MT of coal produced in the corresponding month of the previous fiscal month. This again is a growth of 18.4 per cent. CIL is not receiving any budgetary support from the Government and pay scales are revised based on the profitability of the Company. In fact, CIL has recently paid an interim dividend exceeding Rs.3000 crores to the central exchequer and its executives deserve a better deal than freezing their DA.

Thus, it clearly shows that we executives at CIL have excelled in performance and we deserve an appreciation for our efforts. On the contrary, we are being deprived of our dignity and honour by unjustifiably hitting us financially. This freeze will act further to deplete our PF contribution to Provident Fund and make our post-retirement life humiliating. Considering all these aspects, executives are in a demoralised mental state and agitated. The freezing of DA of executives may lead to a negative growth of coal production and meeting energy demand may be hampered.

In view of the above, we request you to review your decision and repeal the order for implementation of the above in Coal India Ltd and other PSUs.

Manjunath Prasad, as the Hospital denies sending Estimate to WCL on mail

Dear Sir.

Smt. Swarna Gouri Prasad, spouse of our Bonafide member Sri R A M Prasad, (AIACE Membership ID: M-535, Mobile: 9481240217), EIS No. 90109216, Retd Manager (Finance), is under treatment since July 2019 for Breast cancer at HCG Hospital, Bangalore which is empanelled with CIL (at Sl. No. 17 of latest list of CIL empanelled hospitals).

The hospital had earlier extended cashless treatment for the first two cycles of chemotherapy but subsequently refused to do so as they claimed that many of their bills have not been paid by CIL. Since then treatment is being taken against payment at CGHS rates and claiming reimbursement.

However, after review of the latest PET-CT scan, the doctors have proposed a change in treatment cost of which is about Rs.4 lakhs per cycle and treatment consists of 6 cycles which will cost around Rs 24 lakhs.

Hospital says that it has stopped extending cashless treatment, and so, refused to Mail the estimate of treatment cost to WCL, although they have supplied him a copy of this estimate. CMS, WCL has refused to accept this estimate to Mr Prasad and wants it directly on official mail from the Hospital. In between this tussle of rules, it is next to impossible on the part of Sri Prasad to bear such huge expenses for reimbursement at a later stage.

Under these circumstances, it is requested that needful approval may kindly be accorded and communicated to all concerned. CMS, WCL may be advised to allow flexibility in rules and resolve the problem on humanitarian ground and engage for a needful interaction with the hospital.

I am posting his representation of Sri Prasad to us, in Annexure-I.

AIACE requests your kind consent so that needful approval for his cashless treatment / advance payment to hospital at the earliest. This will be a boon to Sri Prasad and his ailing spouse.

My wife, Smt. Swarna Gouri Prasad is under treatment since July 2019 for Breast cancer at HCG Hospital, Bangalore which is empanelled with CIL. The hospital extended cashless treatment for the first two cycles of chemotherapy but subsequently refused to do so as they claimed that many of their bills have not been paid by CIL. Since then treatment is being taken against payment at CGHS rates and claiming reimbursement.

After review of the latest PET-CT scan the doctors have proposed a change in treatment cost of which is about Rs.4 lakhs per cycle and treatment consists of 6 cycles. I requested the hospital to send a Mail to CMS, WCL for getting approval but they have refused saying that since cashless treatment is not available they cannot send mail. However they mailed the estimate to me. Copy is attached. I sent this to CMS, WCL requesting for approval.

CMS, WCL has replied that the mail has to be sent by the hospital. I have explained the circumstances to CMS, WCL and requested to reconsider the issue & send approval. I earnestly request AIACE to help me in this matter. Also since the amount involved is beyond my means and reimbursement is taking 4 to 6 months, I request that the hospital be asked to extend cashless treatment.

CPAO/IT&Tech/Bank Performance/37 (Vol-III)A/2020-21/60 dt. 23-11-2020 issued by Department of Expenditure, Ministry of Finance to make some mandatory introduction of PPO numbers in Pensioners" account by respective Pension Paying Banks. The letter contains 3 points regarding Pension Payment to retirees as follow:-

- 1. The first point refers to various orders by Government in this regard
- 2. The second point refers to disgust of Ministry due to non-implementation of Government's directive by Banks to introduce system of mentioning PPO number of pensioners in their respective Bank accounts
- 3. Finally, the letter has asked Pension Disbursing Agencies to pursue the matter with Pension Paying Branches.

Under the circumstances, we request you to kindly issue advisories to all Pension Paying Branches, disbursing CMPF Pension, to implement this directive. Needless to mention that every Centralized Cell of Pension Paying Banks maintain this record of PPO number vis-à-vis Account number. They have to collect nothing, rather need to make this list available to all Branches for implementation of the above referred order.

We hope that earnest efforts will be made from you end in this regard. It may be mentioned that your earlier advisory to Banks for converting all these Pension accounts into "Former or Survivor" type has not yet been completely implemented and unawareness among Branch Managers still remain a major hurdle.



In fact, WCL is learnt to have introduced these Smart Cards for their beneficiaries much earlier than CIL.

Hence, keeping in mind the inherent advantages associated with Smart Cards, we request that these data for Smart Cards be got transferred from subsidiaries for preparation and distributtion centrally by CIL, HQ. This will hasten the process and ensure uniformity in the system. Sub: <u>Adamant attitude of CMPFO leading to Compulsion of Proposed Dharna for Revision in modalities for Widow</u>
Pension and other reforms under CMPS-1998

Dear Sir,

All India Association of Coal Executives (AIACE) consist of members from Working and Superannuated executives belonging to Coal India and SCCL. We wish to compliment the government, specially the Ministry of Coal, for the excellent work being performed by it to meet the energy demands of our country and simultaneously working for welfare of families in coal sector.

For supporting the needs of post-retired life of workers in coal industry, a Pension scheme is managed and run in the name of CMPS-1998. Interestingly, whereas all the Pension schemes in different sector come under the ambit of Ministry of Labour and Welfare, the pension scheme for coal sector is under the purview of Ministry of Coal under whom Coal Mines Pension Fund Office (CMPFO) operate and oversee the disbursing of Pension.

As notified in Gazette Notification for implementation of CMPS-1998, after crossing a lot of hurdles in submitting various required forms for commencement of pension, an employee is able to receive his Pension Payment Order (PPO) which entitles him to pension benefits. The tragic saga is that, after death of a pensioner, the widow is also required to collect and submit similar papers to the office of last place of working of her husband. Many a times the widows are settled at far off distant remote place of the country, and moreover, the last place of working is also not physically traceable due to Merger-Demerger of units of coal companies. These factors coupled with ailing health condition of widows due to their agemakes it rather impossible to comply with the various requirements which even a living intellectual will find difficult to re-submit. All these ridiculous requirements are only depriving the widows of their legitimate pension rights who opt to forgo their claims OR they fall a prey to spurious middlemen.

To sort out solution for these difficulties, we at AIACE had written various letters to Commissioner, CMPFO vide letter nos. AIACE/CENTRAL/2020 /002 dt. 6.1.2020 followed by another letter no. AIACE/CENTRAL/2020 /039 dt. 9.7.2020 on the above subject but they went on deaf ears. We are made to feel like "Playing music before buffalo."

There are other issues also like revision of pension and DA-linked pension, but, we cannot tolerate the harassment of widows in starting pension after death of their husbands. As such, to make voice heard at the corridor of Decision Makers, Member Pensioners are compelled to go for organising one day Dharna in February, 2021 in front of CMPFO office, Dhanbad along with proposed Relay Dharna at Jantar-Mantar in Delhi, on any day after this date, till our demands are acceded to.

In the light of above facts, we request your specific clear cut direction to concerned officials for making widows' pension hassle free and initiate action for enhancement of CMPS pension as CIL has decided to contribute Rs 10/te of coal to this fund for strengthening it.

It is also requested to constitute an empowered study team of Professionals to know the destitute and impoverished condition of those Pensioners, who have retired before 2007 and languishing at present in spite of their dedicated and best sincere efforts put during their service life to meet the nation's energy demand.







Dear Sir,

The country is currently passing through an unprecedented Covid-19 pandemic and Coal India did a marvelous job by working hard to meet nation's energy demand. It allowed various relaxations in many quarters which motivated the work-force. The board of directors of CIL went further ahead and accorded the approval of payment of ex-gratia of Rs 15 lakh to the next of kin of employees of CIL and its subsidiaries including contract workers dying due to COVID-19 w.e.f March 24, 2020. It is also acting similarly in other areas in line with the directives from Central Government.

However, it is felt that Coal India Ltd failed to understand the difficulties of its retired manpower in visiting the hospitals during Covid-19 pandemic. For several months, hospitals were closed, then resumed partial operations with Partial/Full lockdown in certain parts of the country. Even the government has issued advisories restricting elderly citizens to remain indoors.

Thanks to Central Government, who realized this difficulty as early as on 27-3-2020 and allowed CGHS beneficiaries to purchase repeat medicines for treatment of chronic disease. The said order is continuously being extended and the current order is attached in Annexure.

For want of such clear cut directive from Competent Authorities at CIL and Subsidiary levels, several bills of our member executives are laying unpaid waiting for directions.

Under the circumstances, appropriate relaxation in rules is solicited so that purchase of medicines based on Original Prescriptions of chronic ailments are approved for and released for payment.

In view of the Corona Virus Disease(COVID-19), all out efforts are made by the Government to contain its impact by instituting measures at community as well as at individual level.

- 2. In this regard the undersigned is directed to draw attention is the OM of even number dated 27.03.2020, 29.04.2020 , 29.05.2020 and 24th August 2020 vide which an option has been provided to CGHS beneficiaries getting medicines for Chronic diseases , to purchase medicines based on the prescription held (prescribed by CGHS Medical Officers/CGHS Specialists /other Govt. Specialists/ Specialist of empanelled hospital) till 30th September 2020, irrespective of Non-Availability certificate from CGHS or otherwise. However, several representations are received in the Ministry seeking extension of the period in view of the continued 'Lock Down'.
- 3. The matter has been reviewed by the Ministry and it is now decided, in continuation of the earlier OM on the subject, that CGHS beneficiaries getting medicines for Chronic diseases shall be permitted to purchase medicines based on the prescription held (prescribed by CGHS Medical Officers/CGHS Specialists /other Govt. Specialists/ Specialist of empanelled hospital) till 31st December 2020 on the same conditions as per the earlier OM dated 27.03.2020. It is also clarified that the CGHS Wellness Centres are functional and CGHS beneficiaries also have the option to collect medicines through CGHS Wellness Centres as per normal practice, instead of purchasing from market.

We do hereby present a case of harassment being faced by our member Sri H. K. Choudhury, Retd. P.O. Rajhara Area, CCL, EIS No. 90009986; CMPF No. S/2/35/280; PPO No. 100009100.

He had superannuated in 2006, and is since then fighting relentlessly for rectification of irregularities in calculating his legitimate PF fund and pension fixation due to non-consideration of his service period of 3 years starting from 1-8-1973 when, on appointment, he joined Satgram Area, ECL and had served in Benali and Nimcha collieries till 1991.

Subsequently, on his representation, Sr. Manager (Collieries), Nimcha Colliery, Satgram area, ECL agreed to this contention vide his letter no. NIM/AGT/PD/2017/2407 dt 21-8-2017 notified all concerned for re-fixation of his Pension and PF benefits. (Annexure-I).

After this, 2 more stages are involved. In first stage, the last place of posting (ie in CCL) has to resubmit the Pension calculation, followed by Stage-2 in which CMPF will have to be approached for their needful.

Sadly, the matter still lies in Stage-I since last 3 years, and one fails to wonder how much more time is needed at CCL. Sri Choudhury had approached CCL Pension Adalat and has even telephonically contacted GM(Pension), CCL but is yet to receive any acknowledgement, resolution is a distant matter. (Annexure-II). Relevant V-V statements are also enclosed in Annexures-III and Annexures-IV.

Under the circumstances, AIACE is compelled to request you constitute a dedicated team of CCL (who are liable for the final action from the employer's side) and ECL (who have committed the initial error) personnel for finalizing the case by proper interaction and involvement of CMPF Officials.



Dear Sir,

AIACE is proud to be an association of executives of Coal India Ltd and SCCL, with its members being both WORKING and RETIRED Executives from coal industry.

Coal India Ltd. has implemented a Contributory Post Retirement Medicare Scheme, CPRMSE, with effect from 25th April, 2008. Under this scheme, CIL and its subsidiaries are extending medical facilities to the retired employees and their families through various medical establishments from the dispensary level to the central and apex hospitals in different parts of the coalfields.

Over the years, it has been observed that this scheme suffers from inherent drawbacks which call for several changes/amendments/revision in CPRMSE. From time to time we had been highlighting these issues in the past, and in some cases we have achieved desired results in selective cases.

However, in the present circumstances, we feel that there is a necessity to recast the scheme and to make it more effective. Haphazard selective remedial steps are not going to solve problems lying at various ends from empanelled hospital to CIL management to executive concerned.

Even though CMS department gives us a sympathetic audience, it is felt that, need of the hour is to form an empowered committee of officers – both from CIL side and retired-executive side, to study and understand the difficulties at various levels, in order to recast the scheme.

Retired executives and AIACE members are the worst sufferers and like to be a part of this empowered committee to present the problems, share their varying experiences and suggest remedial measures. Some of the points to be studied by the committee can be as listed below:

jj) Smart medical card to all executives in all subsidiaries under the centralized overall control/supervision of

CIL.

- kk) Cash less Indoor treatment in all empanelled hospitals
- II) A 24x7 call centre to assist/resolve grievances of retired working and retired beneficiaries
- mm) A well notified centralized liaison centre to assist empanelled hospitals towards their claim settlement
- nn) Upward Revision of hospital charges, like many PSUs who have entered into agreements with empanelled hospitals.
- oo) Settlement of OPD medical bills within stipulated time and fixing of responsibility for non-adherence,
- pp) Acceptance of digital life certificate for availing CPRMSE benefits
- qq) Inclusion of eligibility of dibyang children under CPRMSE in line with CPRMSNE
- rr) Appointment of Doctors (specialist and GDMOs) which will encourage retirees to go for company hospitals.

We sincerely hope that our proposal/suggestions will find takers at CIL and your kind approval will follow for constituting such an empowered committee.

However many executives, who retired after 1-1-2017 but before implementation of the revised pay scales, continue to receive pension at the old rates.

Dear Sir,

From the very beginning, we have been reiterating that CIL's CPMRSE is one of the best schemes in PSUs, but it is in a state of comma due to its faulty implementation at ground level. Various amendments and other related office orders have not been centrally stored in any REVISED Edition of CPMRSE documentation. This causes unawareness, at the lowermost level, who commits inadvertent errors in honoring the rules formed for CPRMSE. This leads to disrepute to CIL and harassment to retirees.

In one such amendment, which is still not incorporated in the main documentation of Revised CPMRSE, it has been circulated vide CIL/C-5A/PC)/CPRMSE/2005 dt. 1.4.2017 that,

- In absence of any CIL-empanelled hospital, an executive is allowed to avail treatment in a hospital which is empanelled with other PSUs (Vide Clause 3.2.1(a)(i)
- (Copy enclosed in Annexure-I)

Taking advantage of this amendment, one of our Members, Sri Sat Prakash Gupta, (EIS no. 90015025), Retd GM(E&M), WCL, a CPRMSE Beneficiary from CIL, HQ Kolkata (Card no. is CPRMSE/05/08/108/CIL); residing in Kurukshtera (Haryana) had undertaken treatment at MM Institute of Medical Science and Research, Mulana which is empanelled with Northern Railway and Himachal Government.

It may be reiterated that his nearest CIL-empanelled hospital is 175 km away in Delhi NCR and he also volunteered to submit/apply prior intimation which is not mandatory.

It is a shame on the part of concerned officials that no communication was sent to him, and moreover, his Bill claim was summarily rejected and returned with noting "Hospital not empanelled with CIL". Pity is that his second bill is also pending at CIL, CPMRSE division, and is likely to meet the same fate. He has again written on 15-12-2020 to CMS, CIL, a copy of which has been endorsed to us. (Enclosed in Annexure-II)

Under the circumstances, your kind intervention and instructions are solicited for resolving the issue and reimbursing the due claims to Sri Gupta as well as sensitizing officials involved in Implementation of CPRMSE right from corporate level to lower level.

Clause 3.2.1(a)(i): Where there is no CIL empaneled Hospital at places where the retired executives reside/unable to go to such empaneled hospitals/Diagnostic Centres, the retired Exectives can avail the medical facilities from other PSU hospital/ other PSUs empaneled Hospital, ESI Hospital, Government hospital including hospital under Municipal Corporation or Hospital/Diagnostic Centres empaneled by CGHS subject to CGHS rates for the items covered under CGHS and referred by Company Doctor or other extant guidelines and claim reimbursement of expenses incurred.

Clause 3.2.1(d): No limit will be applicable in case of treatment of following diseases:

(i)Heart and Vascular diseases involving surgical or interventional therapy, (ii) Cancer,(iii) Renal disease, (iv) Paralysis, (v) AIDS & (vi) Addison's disease & Adrenal Histoplasmosis.

Your kind attention is requested to be drawn to the reply sent to us in response to our letter no. AIACE/CENTRAL/2020/129 dt. 22-12-2020 on the above subject. (Copy enclosed in Annexure-I)

This is another proof of inefficiency of dealing authorities in rejecting the legitmate claim of CPMRSE reimbursement to Sri S. P. Gupta.

It is to be noted that rules under CPRMSE have been changing from time to time. The initially adopted CPRMSE has undergone several changes, which were notified from time to time, by issue of relevant Office orders.

- Somewhere in the year 2012, one version of CPRMSE was published mentioning reference of various past Office orders leading to formation of rules. It declared the commencement of scheme with effect from 25.4.2008. (Let it be called OLD or Superseded version.)
- ii. Later on, the above scheme was superseded and amended second version of CPRMSE was published on 28-12-2012 vide CIL/C-5A/PC)/CPRMSE/207 dt. 28.12.2012. This version omitted citation of various office orders amending the existing rules. (Let it be called Ammended version.)
- iii. Fortunately, amendments after 28-12-2012 are still continuing, and unfortunately no revised version of CPRMSE is being published incorporating changes incorporated by various Office orders.

This has led into lack of continuity in interpretation of CPRMSE rules and misjudgment occurs. As such, in the present case, the learned Dy. CMO inferred that amendment of Clause 3.2.1(a)(i) of CPRMSE, vide CIL/C-5A/PC)/CPRMSE/2005 dt. 1.4.2017 allows reimbursement of Indoor only. We contest her arguments, and for her convenience, this amendment in Yellow Bracket is shown in enclosed in <u>Annexure-II</u>. We shall be highly obliged if she is able to find the words INDOOR or OUTDOOR are inscribed in this order.

For convenience of all, both these OLD and AMMENDED versions are enclosed with this letter. Further, covering letter and Page-4 & Page-5 of latest CPMRSE updated on 28-12-2012, are attached herewith as **Annexures-III, IV and V**. Relevant portions of entire Clause 3 of CPMRSE are highlighted in yellow colour. Explaining the contents of these pages will be a waste of precious time of the Chairman of our company. In the light of amendment vide CIL/C-5A/PC)/CPRMSE/2005 dt. 1.4.2017, various subsidiaries have issued office orders, and one order issued by CMPDI is attached as **Annexure-V**I.

Needless to say, these contents confirm that both Indoor and Outdoor treatment in empanelled hospitals are reimbursable and, Sri Gupta is entitled for full reimbursement which is requested for grant of competent approval.

Sub: Callousness in CPRMSE claim settlement of Sri S P Gupta, Card no. CPRMSE/05/08/108/CIL)

Dear Sir,

From the very beginning, we have been reiterating that CIL's CPMRSE is one of the best schemes in PSUs, but it is in a state of comma due to its faulty implementation at ground level. Various amendments and other related office orders have not been centrally stored in any REVISED Edition of CPMRSE documentation. This causes unawareness, at the lowermost level, who commits inadvertent errors in honoring the rules formed for CPRMSE. This leads to disrepute to CIL and harassment to retirees.

In one such amendment, which is still not incorporated in the main documentation of Revised CPMRSE, it has been circulated vide CIL/C-5A/PC)/CPRMSE/2005 dt. 1.4.2017 that,

- In absence of any CIL-empanelled hospital, an executive is allowed to avail treatment in a hospital which is empanelled with other PSUs (Vide Clause 3.2.1(a)(i)
- (Copy enclosed in Annexure-I)

Taking advantage of this amendment, one of our Members, Sri Sat Prakash Gupta, (EIS no. 90015025), Retd GM(E&M), WCL, a CPRMSE Beneficiary from CIL, HQ Kolkata (Card no. is CPRMSE/05/08/108/CIL); residing in Kurukshtera (Haryana) had undertaken treatment at MM Institute of Medical Science and Research, Mulana which is empanelled with Northern Railway and Himachal Government.

It may be reiterated that his nearest CIL-empanelled hospital is 175 km away in Delhi NCR and he also volunteered to submit/apply prior intimation which is not mandatory.

It is a shame on the part of concerned officials that no communication was sent to him, and moreover, his Bill claim was summarily rejected and returned with noting "Hospital not empanelled with CIL". Pity is that his second bill is also pending at CIL, CPMRSE division, and is likely to meet the same fate. He has again written on 15-12-2020 to CMS, CIL, a copy of which has been endorsed to us. (Enclosed in Annexure-II)

Under the circumstances, your kind intervention and instructions are solicited for resolving the issue and reimbursing the due claims to Sri Gupta as well as sensitizing officials involved in Implementation of CPRMSE right from corporate level to lower level.

Clause 3.2.1(a)(i): Where there is no CIL empaneled Hospital at places where the retired executives reside/unable to go to such empaneled hospitals/Diagnostic Centres, the retired Exectives can avail the medical facilities from other PSU hospital/ other PSUs empaneled Hospital, ESI Hospital, Government hospital including hospital under Municipal Corporation or Hospital/Diagnostic Centres empaneled by CGHS subject to CGHS rates for the items covered under CGHS and referred by Company Doctor or other extant guidelines and claim reimbursement of expenses incurred.

Clause 3.2.1(d): No limit will be applicable in case of treatment of following diseases:

(i)Heart and Vascular diseases involving surgical or interventional therapy, (ii) Cancer, (iii) Renal disease, (iv) Paralysis, (v) AIDS & (vi) Addison's disease & Adrenal Histoplasmosis.

The Board of Directors of CIL in their 289th Meeting held on 18.09.2012 has approved the modifications/additions in the Contributory Post Retirement Medicare Scheme for Executives of CIL and its Subsidiaries (CPRMSE).

The payment of outpatient/domiciliary treatment as per clause 6.1 will be effective from 01.01.2013. The payment of outpatient/domiciliary treatment for the period 01.07.2012 to 31.12.2012 will be as per the pre-revised rates.

The reimbursement of charges for hospitalization (indoor treatment) as per CPRMSE has been enhanced to Rs.25 lakhs or Rs.12.5 lakhs as the case may be with immediate effect. There will be no limit for specified diseases as mentioned in clause 3.2.1. (d) of the Scheme, which will not be accounted against the amount of Rs.25 lakhs or Rs.12.5 lakhs as the case may be.

The Contributory Post Retirement Medicare Scheme for Executives of CIL and its Subsidiaries (CPRMSE) as modified is published in website www.coalindia.in. A copy of the same is enclosed for vide circulation.

3.0 BENEFITS

- The Medical Benefits to the retired executives and their spouses under the scheme will be admissible for the treatment taken only within India and would be regulated as under: Traveling expenses or allowance would not be admitted for journey undertaken for the purpose of obtaining Indoor or Outdoor treatment either for self or spouse. In case of ambulatory patient, ambulance charges will be paid in case the ambulance is provided by the Empanelled hospitals. 3.1
- Reimbursement of medical expenses for indoor and outdoor treatment will be regulated on the following terms and conditions:-

3.2.1 Indoor Treatment

- i) Reimbursement of Medical expenses incurred for indoor treatment will be allowed on actual basis, subject to the condition that the treatment is obtained in Company hospitals, Government hospitals including hospitals under Municipal Corporation and all other PSUs. Besides, Medical expenses will also be reimbursed for treatment undertaken in hospitals notified by Coal India Ltd. as per actual or CGHS rate whichever is less
 - ii) In case of emergency, like Heart attack, accidents, etc., or due to non-availability of empanelled hospitals in a particular town or city, if any retired executive and/or spouse undertake medical treatment in hospitals/ nursing homes other than mentioned above, the reimbursement will be admissible as per prevailing MAR rate. Such payments will be released on case to case basis on obtaining approval of Dir. (P&IR), CIL or CMDs of the subsidiary companies as the case may be.

Further in such situations if treatment is received in NABH accredited or super speciality hospital, reimbursement will be restricted to maximum MAR rates.

However, in case treatment is undergone in Company approved Hospitals or Nursing Homes, reimbursement will be done as per actual or CGHS rate whichever is less. Where CGHS rate is not available, payment should be made as per MAR.

In case of treatment undertaken in non- empanelled hospitals in non-emergency situations prior intimation should be given to the respective CMS of subsidiary companies or Dy. CMO, CIL as the case may be. In all such cases payment will be released on case to case basis as per MAR, on obtaining approval of Dir. (P&IR), CIL or CMDs of the subsidiary companies as the case may be.

- iii) 100% Cashless Treatment shall be permitted at the empanelled hospitals or hospitals notified by $\mbox{CIL}\ .$
- iv) However, in case of any inadmissible amount, the same shall be adjusted in future from half-yearly payment or from any other amount payable to the retired executive/spouse as the case may be.

For the treatment obtained at company's hospitals by the members/spouses, no charges will be charged from the members/spouses. However, for the purpose of accounting under the scheme, a notional rate of 40% treatment cost will be charged to the retired executive

The maximum amount reimbursable during the entire life for the retired executives and spouse taken together would be Rs. 25 lakhs and in case of single membership the limit would be Rs. 12.5 lakhs. This limit should be applicable in respect of General Diseases only i.e., other than the diseases for which the upper limit is not applicable.

Cost of treatment in OPD of empanelled hospitals would also be permitted and the same will be adjusted against the maximum applicable limit of Rs. 25 lakhs or Rs. 12.5 lakhs as the case may be.

- d) No limit will be applicable in case of the treatment of the following diseases:
 - (i) Heart and Vascular diseases involving surgical or interventional therapy, (ii) Cancer (iii) Renal disease (iv) Paralysis (v) AIDS

The detailed clarification of the diseases for which there is no limit and for which medical treatment will be provided is furnished below:

- i) Heart disease including surgical Interventions: This will include (1) Coronary Artery By Pass Grafting (2) Coronary Angioplasty including cost of stent (3) Pacemaker implantation including cost of Pacemaker (3) Any other surgical intervention required for heart disease. Payment may be made on actual basis or on the basis of CGHS approved rate whichever is less.
- ii) Cancer: This will include (1) cost of Chemotherapy taken at home as prescribed by the concerned Oncologist of notified hospital provided the cost does not exceed the cost of Chemotherapy taken at Indoor or Day Care Centre. (2) cost of investigation for follow up treatment of Cancer patient to evaluate progress and metastasis (may be twice in a year or more) based on advice of the concerned Oncologist of the notified hospital (3) cost of Palliative treatment i.e., end stage treatment of cancer patients at home. Payment may be made on actual basis or on the basis of CGHS approved rate whichever is less.
- iii) Renal Disease: This will include Peritoneal Dialysis including CAPD (Continuous Ambulatory Peritoneal Dialysis) taken at (1) Indoor i.e., hospital (2) Day Care (3) At home provided the cost does not exceed the cost of dialysis taken at Day Care or Indoor. Payment may be made on actual basis or on the basis of CGHS approved rate whichever is less. Organ failure inclusive of transplant and follow up outdoor treatment will also be included.
- iv) Paralysis: The term may be defined as "Neurological Disorder" instead of Paralysis. This will include (1) Surgery Brain & Spine Surgery (2) Cerebra Vascular Accident (3) Cost of Pacemaker in Brain Surgery (deep brain stimulation surgery) (3) Physiotherapy Payment may be made on actual basis or on the basis of CGHS approved rate whichever is less. Cost of DBS implants, intrathecal pumps and spinal stimulators cord physiotherapy (both indoor and outdoor/domiciliary) will be reimbursed as per CGHS rates or actual whichever is less.

Guidelines for availing OPD treatment by retired executives registered under CPRMSE in Company's Sub: hospitals/ Dispensaries.

In pursuance of decision taken in Functional Director's meeting held on 10.12.2016, the Competent Authority has kindly accorded approval for allowing OPD treatment to retired executives registered under CPRMSE in Company's hospitals/Dispensaries as mentioned below.

- Retired executives registered under CPRMSE are now allowed to avail treatment at CMPDI Dispensary as Nonentitled case.No medicine will be supplied to them. They need not to pay any amount for consultation in cash/kind.CMPDI Dispensary will maintain a register for recording of each consultation availed by them. At the end of every month, list of such members alongwith number of consultation made during the month will be sent to Finance Division for recovery @ Rs.75/- for each consultation from fixed amount of Rs.25 lakhs or 12.5 lakhs, as the case may be.Cost of medicines/ pathological test/investigations etc. as prescribed by the Company's doctor will be reimbursed as per rule and to be adjusted from fixed amount of Rs.25 lakhs or 12.5 lakhs as the case may be
- Retired executives registered under CPRMSE are now allowed to avail OPD treatment in Company's Hospital/Dispensaries owned by other subsidiaries of CIL.Reimbursement of consultation fee together with Cost of medicines/pathological test/investigations etc. as prescribed by the Company's doctor will be reimbursed as per rule. The reimbursed amount is to be adjusted from fixed amount of Rs.25 lakhs or 12.5 lakhs as the case
