A Meeting was held on 5-3-2021 between Sri A. Bharti, Economic Advisor, Ministry of Coal & 5-member delegation from All India Association of Coal Executives in Room no. 119, F-wing, Shastri Bhawan, New Delhi.

The AIACE team, consisting of the following members, was able to present the facts as annexed herewith:-

In subsequent paragraphs, summarised presentation of facts by AIACE and resultant outcome of the meeting is shown in tabular form. The official record notes of meeting is under preparation and will be made available to us after perusal of Secretary (Coal).

The meeting concluded with positive note. We were assured of our future access to Ministry whenever situation warrants that.

ISSUE	OUR CONTENTION	BRIEF OUTCOME OF MEETING
1) NPS issue (CIL Executive Defined Contributory Pension Scheme issue)	Payment of long pending Interest on NPS due to its delayed implementation	We were informed that this matter was unnecessarily forwarded to Coal Ministry and was well within the jurisdiction of CIL. Now, this matter is pending with DPE where it has been forwarded for opinion. Sri Bharti agreed to send fortnightly reminders to DPE for early opinion so that CIL could be communicated accordingly.
2) Pension issue	Long awaited revision and simplification of CMPFO Rules for starting pension to spouse of deceased pensioner	<p>The Actuary report under preparation at present, will be uploaded on website on which comments will be invited to secure strengthening of Pension fund. He was glad to hear our suggestions on this and has asked AIACE to submit it to him immediately for consideration by Actuary. We agreed to this. He said certain measures are being thought of for pension fund sustainability for pension review. Details can be divulged at a later stage only. During discussions it emerged that doors are always open for CIL to take over management and control of present CMPF Trust. This step can ensure the past employees of coal industry with a secured post-retirement life as well.</p> <p>On demand of reforms and simplification in starting widow/widower pension, he was surprised to know that still employers are insisting for Form PS-1 and PS-2. He assured that there is no such need and collieries will be advised accordingly. Further he directed his subordinates in CMPFO to go for a 24x7 email helpline for such widows/widowers to whom CMPFO will send representatives to complete the formalities. Further he agreed to examine the proposal of involving Banks for this purpose of needful documentation.</p>
3) CPRMSE issue	Removal of bottlenecks in Post-retirement medical care scheme for executives.	We were asked to take this matter at CIL who are well equipped for ensuring reforms.
4) PRP issue	Payment of PRP to executives who failed to submit PRIDE due to various reasons	We were told that this matter can be resolved at CIL level itself. He agreed to advise CIL accordingly.

5) Unviable Mines issue -	Closure of unviable underground mines and transfer of executives and employees in productive mines.	He agreed to this demand and informed that steps are being taken on regular basis. He asked us to submit a detailed suggestion, if any, at a later stage.
6)	Scooter India Ltd. issue - Feasibility of absorbing 42 executives from ailing Scooter India Ltd into Coal India Ltd	We had raised this issue to enable recruitment of experienced technocrats from an ailing industry into CIL at an entry-level cost. However, this proposal was not taken up for discussion on the ground that it is beyond the purview of Coal Ministry.
7) AIACE Representation -	Representation of AIACE in various statutory bodies like a) CMPF Trust, b) CIL Executives Defined contribution pension trust, c) CPRMSE trust d) Mine Safety committee(s) at i) Ministry level, ii) CIL level, iii) Subsidiary level and iv) Area level.	This demand was agreed in principle. The modalities can be framed subsequently.
8) Any other issue -	Any other issues which you may like to share/discuss with us	Issue of reinstating Coal Field Allowance and some other issues on perks were taken up. We were advised to take this issue up during subsequent pay revisions.
