CORE TEAM OF AIACE CARES!

The Core Team of AIACE, consisting of dedicated members with experience in varied fields and located at different cities, is always there to help the members solve their problems. The Team Members use their resources and contacts to the benefit of members. Once an issue is raised in the WhatsApp group, the members immediately assist in solving it.

The most common issues faced by the members, especially Associate members are as follows.

1. CPRMSE 3. Pension

2. NPS 4. PRP

A. CPRMSE ISSUES

- i. A common problem is obtaining Medical Card. The Core Team guides the members as to how to obtain the Medical Card and provides the necessary support.
- ii. Hospitalisation and reimbursement of medical expenses. List of empanelled hospitals is made available on our website aiace.co.in and also in the WhatsApp groups. Members are given assistance to get cashless treatment and where this is not extended, the Team helps in getting the reimbursement.
- iii. When a member needs hospitalisation in a different city, the local branch in that city helps in all possible ways.

B. NPS ISSUES

- i. The Core Team has assisted the members in filing profile form on CIL website for NPS. This was crucial to many Associate members who were not even aware of NPS.
- ii. The cases are followed-up with CIL to ensure early settlement.
- iii. Help is also given in submission of Life Certificate to different ASPs.

C. PENSION

- Executives retired between 1-1-2017 and 31-10-2018 were entitled to enhancement of pension due to pay revision. AIACE raised this issue and the Core Team compiled all the required details. Almost all cases have now been settled.
- ii. The matter of arrears of pension to executives retired between 1-10-2020 and 30-06-2021 due to freezing of DA has also been taken up.
- iii. Jeevan Pramaan camps are conducted every year. MOU has been signed with India Post to issue Jeevan Pramaan.

D. PRP

Many executives could not file their performance report in the year of retirement due to various reasons. AIACE took up the matter with CIL and successfully solved a number of cases.

Informative articles on different topics such as CPRMSE, NPS, Income Tax, Pension claims have been prepared. These articles and various forms required such as SAHAJ for pension, Life Certificate, Medical Reimbursement, etc., are available on the website of AIACE."

MINUTES OF ZOOM MEETING HELD ON 17TH JULY 2022

A virtual meet on ZOOM was held on 17th July 2022 from 11:00 AM in two Sessions of 40 minutes each. It was attended by about 35 members from across the country. The purpose of the meeting was to finalise the arrangements for Dharna to be organised from 25th July to 31st August 2022 at Jantar Mantar, New Delhi to press our demand of review and revision of pension under CMPS-1998. Sri. P.K.Singh Rathor, Convenor, AICPA/AIACE, welcomed the members and requested Dr.B.K.Srivastav, Vice-President, AIACE to preside over the meeting and give updates on the matter.

Dr.B.K.Srivastav informed the members that arrangements for boarding & lodging have been made at the following address.

Participants should first reach the allocated accommodation at Paharganj, Delhi and then proceed to the Dharna site which is very nearby. The distance from different Railway Stations at Delhi to Paharganj are given below and local transport is available.

- 1. NEW DELHI Railway Station to PAHARGANJ- 1 km
- 2. H. NIZAMUDDIN Railway Station to PAHARGANJ- 11 kms
- 3. ANAND VIHAR Railway Station to PAHARGANJ- 12 kms

In case of any medical emergency a Doctor will also be in attendance on all days. Our member Dr. V.S. Tiwari, Noida has agreed to be available and Dr. N.G.Mukherjee, Asansol and Dr. A.M.Mohan, Bilaspur have also volunteered to be present on certain dates. A meeting and press conference will be held at Delhi at 4:00 PM on 24th July 2022. A second press conference will be held in 1st week of August 2022. Permission has been obtained for the Dharna up to 12-08-2022 and we will apply for permission for the further period.

Sri.P.K.Singh Rathor said that the Dharna will be from 10 AM to 4 PM daily. Details of all the participants are to be recorded in a Register on each day. After 4 PM members in batches of 4-5 persons are to approach their Members of Parliament and submit a memorandum on review and revision of pension. We will also invite a few MPs to address the gathering. He stressed that the Dharna should be peaceful, orderly and there should be no slogans condemning anyone.

Sri. Manjunath Prasad requested all the participants to confirm their dates and to carry their original ID Cards. It would be helpful if the weather forecast of Delhi is updated one or two days before the commencement of each batch.

Sri. Arun Singh of Ranchi Branch said that they are trying to mobilise more volunteers from Ranchi. He was requested to give details of the members agreeing to participate in the Dharna.

Sri Ramachander Rao of SCCL wanted to know the medical facilities available at the Dharna site and also suggested to meet Sri Pralhad Joshi, MOC. He was informed by the Convener that Doctors will be available at the site. It was not possible to get an appointment with Sri Pralhad Joshi in spite of our efforts.

Sri Pawan Tandon of Asansol said that everyone should observe COVID protocol. He suggested that extra masks and sanitisers be available. He advised that volunteers should carry their medical cards with them.

Sri R.K.Chowrasia of Bengaluru said that he was disappointed with the response of the members and he will mobilise more volunteers.

Dr. N.G.Mukherjee said that in view of the fact that all the volunteers are senior citizens, a canopy should be provided at the site of Dharna and also proper arrangements of drinking water and toilet facilities should be there. Also a vehicle should be available for transporting any volunteer to the nearest hospital in case of any emergency.

Sri Alavandar Venu Madhav of SCCL suggested that a campaign to highlight the plight of pensioners should be started on social media like Twitter etc.

Sri Muslim Ansari expressed his satisfaction at the way the preparations for the Dharna are progressing. He hoped that we can achieve our goal with this Dharna or else we may have to resort to other means.

Sri P. K. Singh Rathor requested Sri. R.B.Mathur, President, AIACE to invite Sri. R.B.Upadhyay, President, Federation of Retired Employees also to attend our Dharna. Sri Mathur assured that he will do so. Sri Mathur advised the organisers to provide fans and electrical connections at the site.

श्री पी के सिंह राठौर ने कहा कि धरना प्रतिदिन सुबह 10 बजे से शाम 4 बजे तक होगा। सभी प्रतिभागियों का विवरण प्रत्येक दिन एक रजिस्टर में दर्ज किया जाना है। शाम 4 बजे के बाद 4-5 व्यक्तियों के जत्थों में सदस्यों को अपने संसद सदस्यों से संपर्क करना है और पेंशन की समीक्षा और संशोधन पर एक ज्ञापन प्रस्तुत करना है। हम सभा को संबोधित करने के लिए कुछ सांसदों को भी आमंत्रित करेंगे। उन्होंने जोर देकर कहा कि धरना शांतिपूर्ण, व व्यवस्थित होना चाहिए और किसी की निंदा करने वाले नारे नहीं लगाने चाहिए।

श्री. मंजूनाथ प्रसाद ने सभी प्रतिभागियों से अपनी तिथियों की पुष्टि करने और अपने मूल पहचान पत्र ले जाने का अनुरोध किया। यह मददगार होगा यदि प्रत्येक बैच के शुरू होने से एक या दो दिन पहले दिल्ली का मौसम पूर्वानुमान दे दिया जाए।

रांची शाखा के श्री अरुण सिंह ने कहा कि वे रांची से अधिक से अधिक स्वयंसेवकों को जुटाने का प्रयास कर रहे हैं। उनसे धरने में भाग लेने के लिए सहमत सदस्यों का विवरण देने का अनुरोध किया गया था। एससीसीएल के श्री रामचंद्र राव ने धरना स्थल पर उपलब्ध चिकित्सा सुविधाओं को जानना चाहा और श्री प्रल्हाद जोशी, माननीय कोयला मंत्री से मिलने का भी सुझाव दिया। संयोजक द्वारा उन्हें बताया गया कि मौके पर चिकित्सक उपलब्ध रहेंगे। हमारे प्रयासों के बावजूद श्री प्रह्लाद जोशी से मिलने का समय नहीं मिल सका।

आसनसोल के श्री पवन टंडन ने कहा कि सभी को कोविड प्रोटोकॉल का पालन करना चाहिए। उन्होंने सुझाव दिया कि अतिरिक्त मास्क और सैनिटाइज़र उपलब्ध हों। उन्होंने सलाह दी कि स्वयंसेवकों को अपना मेडिकल कार्ड अपने साथ रखना चाहिए।

बेंगलुरु के श्री आरके चौरसिया ने कहा कि वह इच्छुक सदस्यों की संख्या से निराश हैं और वह और अधिक संख्या में स्वयंसेवकों को जुटाएंगे।

डॉ. एन.जी.मुखर्जी ने कहा कि सभी स्वयंसेवक विरष्ठ नागरिक हैं, इसे देखते हुए धरना स्थल पर शामियाने की व्यवस्था की जाए और पीने के पानी और शौचालय की भी समुचित व्यवस्था की जाए. साथ ही किसी भी आपात स्थिति में किसी स्वयंसेवक को नजदीकी अस्पताल ले जाने के लिए वाहन उपलब्ध होना चाहिए।

एससीसीएल के श्री अलवंदर वेणु माधव ने सुझाव दिया कि सोशल मीडिया जैसे ट्विटर आदि पर पेंशनभोगियों की दुर्दशा को उजागर करने के लिए एक अभियान शुरू किया जाना चाहिए।

धरने की तैयारियां जिस तरह आगे बढ़ रही हैं, उस पर श्री मुस्लिम अंसारी ने संतोष जताया। उन्होंने आशा व्यक्त की कि हम इस धरने से अपने लक्ष्य को प्राप्त कर सकते हैं अन्यथा हमें अन्य साधनों का सहारा लेना पड़ सकता है।

श्री पी के सिंह राठौर ने श्री. आरबी माथुर, अध्यक्ष, एआईएसीई से अनुरोध किया कि वे श्री आरबी उपाध्याय, अध्यक्ष, सेवानिवृत्त कर्मचारी संघ को भी हमारे धरने में शामिल होने के लिए आमंत्रित करें। श्री माथुर ने आश्वासन दिया कि वह ऐसा करेंगे। श्री माथुर ने आयोजकों को स्थल पर पंखे और बिजली के कनेक्शन उपलब्ध कराने की सलाह दी।

MINUTES OF ZOOM MEETING HELD ON 21ST AUGUST 2022

A virtual meet on ZOOM was held on 21st August 2022 from 6:00 PM in two Sessions of 40 minutes each. It was attended by members from across the country. The purpose of the meeting was to finalise further course of action to be adopted for revision of Pension Scheme 1998.

Dr.B.K.Srivastav presided over the meeting and informed that in view of the answer given by the Hon'ble Minister of Coal in the Rajya Sabha that under the present circumstances there is no possibility to reise the pension, we have to intensify our struggle for revision. He informed that the Board of Trustees, CMPF, during the meeting on 16th August 2022 at Nagpur discussed the matter of extending the voluntary cess of Rs.14 per MT of non-coking coal to all types of coal and to make it mandatory. But a final decision in this regard will only be taken in the next meeting of BOT and then CMPS Act has to be suitably amended by parliament. Also report of the Actuary is awaited. This is nothing but eyewash and delay tactics adopted by CMPFO and has been going on for many years. We should continue our protest until a concrete decision is not taken.

Sri. P.K.Singh Rathor told that Dharna staged at Jantar mantar in July 2022 has had an effect and our demand for revision of pension was discussed by BOT, CMPF was discussed at their meeting held on 16-8-2022. He requested Sri. D.R.Jharbade, General Secretary, AICPA to give details of their meeting with BOT members at Nagpur.

Sri. D.R.Jharbade said that representatives of AICPA met Sri. Rakesh Kumar, Chairman, BOT, Sri. A.K.Jain, Secretary, MOC and Sri. P.Agarwal, Chairman, CIL and submitted a memorandum of demands by AICPA. Sri. Rakesh Kumar informed us that the matter will be discussed in detail in the next meeting of BOT that is scheduled after 3 months. The issue was also discussed with Sri. A.K.Jain and Sri P.Agarwal who reacted positively to the matter. Sri. Rakesh Kumar assured that the minutes of the meeting will be sent to AICPA.

Sri. P.K.Singh Rathor said discussion is going on for fixing the minimum pension at Rs.1000. Officials at every level have realised that the pension under CMPS should be enhanced. We have taken a momentous decision today to observe Dharna at the Headquarters of CMPF at Dhanbad and all the Regional Offices on **10**th **October 2022** and to organise a massive rally at New Delhi on **5**th **December 2022**. He requested all the members to participate in these dharnas in large numbers and make our protest rally a resounding success. All Branches are advised to hold meetings and finalise the list of members who will attend

the Dharnas. He congratulated AICPA, Betul Branch for their active participation in Dharna in July 22, successful meeting with BOT and for their suggestion to prepare a flag of AICPA.

MINUTES OF ANNUAL GENERAL BODY MEETING HELD ON

8TH SEPTEMBER 2022

The Annual General Body Meeting of AIACE was held virtually on ZOOM platform on 8th September 2022. The Agenda for the meeting was as follows.

- 1. Adoption of Audited Accounts for the year 2021.
- 2. Deciding the date and venue for election of Central Committee
- 3. Dharna in front of CMPFO across the country on 10-10-2022 and Dharna at New Delhi on 05-12-2022 for review and restructuring of CMPS,1998 to allow revision of Pension in line with IBA
- 4. Membership drive from September'22 to December'22
- 5. Activity report of AIACE and achievement
- 6. Activation of CIEWA (Coal India Executives Wives' Association in different cities
- 7. Submission of Life Certificate for CMPS Pension
- 8. Empanelment of hospitals in different cities and reimbursement of bills
- 9. Interest on NPS
- 10. Reorganisation of Branches and WhatsApp groups of AIACE

P.K.Singh Rathor, Principal General Secretary/Convener, AIACE welcomed all the participants and requested Dr.B.K.Srivastav to preside over the meeting.

Homage was paid to the following dear departed members by observing 1 minute's silence.

- 1. Dr. A.K.Dubey (M-180)
- 2. Sri. V.K.Srivastav (M-1418)

Sri. R.A.Manjunath Prasad raised a point of order stating that as per the Bye-Laws of AIACE, required quorum of $1/3^{rd}$ of active members should be there to conduct AGM. In absence of quorum, the meeting was deferred for 30 minutes and AGM was held as per rules.

The following points as per the Agenda were discussed.

1. ADOPTION OF AUDITED ANNUAL ACCOUNTS FOR THE YEAR 2021.

P.K.Singh Rathor read out the accounts and explained the salient points. Sri. Swapanlal Choudhury whether any rules/norms have been framed for exercising control over expenses. It was replied that considering the size of the Association and the volume of transactions, it is not felt necessary to frames any such rules. Expenses incurred by members on behalf of AIACE are in

consultation with the Convenor and Vice-President and are reimbursed post-facto after ascertaining the reasonability of the amount. Sri Choudhury stated that expenses under some of the heads of accounts are mixed up- for e.g. Meeting expenses contain travelling expenses etc. It was clarified that amounts are booked under broad identification as sometimes combined bills are submitted. Detailed bifurcation/classification is neither practical nor necessary. Considering that total expenses for the year is Rs.4.43 lakhs only sufficient details are given.

Sri. Manjunath Prasad raised a query that out of the total amount of Rs. 1.97 lakhs under Meeting Expenses, Rs. 1.34 lakhs (68%) has been paid to Dhanbad, Asansol and Ranchi Branches and this needs clarification. It was clarified that the expenses of these branches are high due to organisation of Dharna on 15-02-2021 at Dhanbad, Ranchi and Asansol in front of CMPFO and also due to fast unto death call by Sri H K Choudhary and for negotiation with CMPFO officials, meetings of members were organised. Participants from different Branches were provided accommodation etc. These are not regular expenses. It was suggested that next time such non-regular expenses be shown separately to avoid confusion.

Sri. R.K.Chowrasia asked for details of amount booked under Office Expenses. It was clarified that we are maintaining offices at Bilaspur, Dhanbad Delhi, Bengaluru, Asansol and other places and the consolidated amounts of these offices are booked under Office Expenses.

Members unanimously agreed to adopt the audited accounts.

2. ELECTION OF CENTRAL COMMITTEE MEMBERS

As per rules the term of the Central Committee is for 3 years and the last election was held in July 2019 and elections are to be held before November 2022. The Electoral College consists of Branch Executive Members. Sri. Pawn Tandon was of the opinion that the Convenor may be empowered to nominate the members of the Central Committee. The Convenor clarified that

physical meeting to elect the central committee members is necessary and the results are to be intimated to the Registrar of Trade Unions.

Sri Kamal Narayan Prasad said that each Central Committee members should be supported by at least 10 members so that only deserving candidates are elected. However as per the Bye-Laws of AIACE, nomination of a member is to be proposed by one member and seconded by another. Thereafter either election or nomination will take place.

Members agreed that election to the Central Committee be held at Bilaspur on 16th October 2022 and all Branch Committee members are requested to attend the same.

3. DHARNA AT CMPF OFFICES ACROSS THE COUNTRY AND DHARNA AT NEW DELHI

It is proposed to organise a Dharna in front of all the Offices of CMPF on 10th October 2022 and a grand Dharna at New Delhi on 5th December 2022 to for review and restructuring of CMPS, 1998 to allow revision of Pension in line with IBA. Members of AIACPA, AIACE and various other organisations of pensioners will participate in these dharnas. The dharna at CMPFOs will be from 10 AM to 1 PM and all members are requested to join in great numbers to make it a success. Members residing at Varanasi can join the dharna at Singrauli and those residing in South India can attend at either Ramagundam or Nagpur. If sufficient number of members come to Delhi the dharna may be held at Ramlila Grounds or any other suitable place.

4. MEMBERSHIP DRIVE

All members are requested to enrol at least 5-6 new members, especially working executives, during the period September-December 2022. Retired executives will not be given membership of AIACE after 31-12-2022. One of the members said that the admission fee of Rs.5000 is too high and many are reluctant to pay this amount. It may be noted that due to the efforts of AIACE, we are now getting enhanced OPD Payment of Rs.36000 p.a. and Interest on NPS and the retired executives are getting good benefits. In light of this Rs.5000 is not at all high. Also, executives who want to join AIACE for personal gains are not at all wanted by us. It was also informed that AIACE is running Benevolent Fund and Rs 10000/is given to spouse in case of death of member. If any members dies before paying Rs 10000/ to the AIACE, still his/her spouse will get Rs 10000. In case a member joins at the age of 60 years, maximum amount, he will pay to the association will be Rs 12500/ at the present rate till achieving the age of 75 years and after 75 years of age, he is exempted from paying annual fee. The convenor told that AIACE runs on the principle of SSS(Self less service to the society)

and its members are always ready to help others in resolving the issues. But members should note that there no place in the association for them who want to join this with exclusively personal purpose. He further told that recently many members have joined with selfish motive only. All members were advised to make aggressive membership drive between Sept-Dec22 but must see their motive before allowing them membership.

6. ACTIVATION OF CIEWA (Coal India Executives Wives' Association)

It was decided to activate CIEWA at different places and the ladies are requested to come forward and participate actively in different initiatives taken by AIACE.

7. ACTIVITY REPORT AND ACHIEVEMENT OF AIACE

Sri Manjunath Prasad presented the activity report and achievements of AIACE. The Dharna organised at Jantar-Mantar, New Delhi in July 2022 was a grand success so much so that after Intelligence Bureau gave its report, we were denied permission by the Police from fifth day. The Hon'ble Minister of Coal has not said that pension will not be revised. The Members of the Board of Trustees, CMPF, who were met by AICPA & AIACE members at Nagpur on 16-08-2022 have also reacted positively to our demands. We have submitted memorandum of demand to various Members of Parliament and have received their support in the matter. It is because of the constant efforts of AIACE that OPD payment under CPRMSE has been enhanced to Rs.36000 p.a and Interest on NPS has been finalised and will be paid shortly.

The Core Team members are tirelessly working to help the members, especially the Associate Members in resolving their issues like widow pension, issue of medical card, medical reimbursement. Launching of AIACE Members' Benevolent Fund at the Foundation day Function held at Bengaluru on 16th May 2022 is another remarkable achievement. Amount of Rs.10000 each as per the scheme has been disbursed to Smt. Sangita Dubey w/o Late Dr.A.K.Dubey (M-180) on 17/8/2022 and to Smt. Latika Srivastava w/o Late Sri. V.K.Srivastava (M-1418) on 10/9/2022.

8. SUBMISSION OF LIFE CERTIFICATE FOR CMPS

All the Branches are advised to hold a meeting in November 2022 and generate Life Certificate of its members. AIACE has MOU with India Post Payment Bank and members can avail their services at home also for a nominal charge of Rs.70. Sri. R.K.Chowrasia, General Secretary, Bengaluru Branch confirmed that Jeevan Pramaan camp and family get-together will be organised at Bengaluru for our members. We will generate Digital Life Certificate for CPRMSE also. It was pointed out by Sri Manjunath Prasad that Jeevan Pramaan generated in November 2021 was not accepted by Subsidiary Companies who insisted on submission of hard copy of

life certificate in revised format. Convenor said that during his visit to Nagpur he took up the matter with CMS and Finance Executives of WCL and the matter is now resolved and there will not be any such problem this year. It should be noted that all beneficiaries have to update their data on CPRMSE portal as per earlier circular details of which will again be posted shortly in WhatsApp groups. Sri Man Mohan Yadav wanted to know how to submit Life Certificate for NPS Annuity. It was clarified that all details on this are available on our website.

9. EMPANELMENT OF HOSPITALS

AIACE has approached CIL to empanel hospitals in each district as retired employees have to travel a long distance to existing hospitals that are far away. They now have the option of taking medical treatment at any Government/CGHS Hospital on payment basis and the expenses will be reimbursed as per rules. It is brought to the notice of members that empanelled hospital has to send e-Mail to CMS of the concerned Subsidiary for approval of cashless treatment.

Some members wanted certain hospitals to be empanelled by CIL. As per CIL policy, the hospitals have to apply for empanelment and AIACE will facilitate the process of empanelment.

10.INTEREST ON NPS

Interest on CIL Executive Defined Contribution Pension Scheme (NPS) has been computed, audited and uploaded on CIL Pension portal. Members can download the details. The interest will be disbursed shortly.

Sri. Kurrey stated that the interest has been calculated correctly. Sri Manjunath Prasad pointed out that the following two points are to be taken up with CIL after the interest is disbursed:

- i. Limiting factor has been used to restrict the interest so that total value of perquisites (including interest) does not exceed 30% of the salary. But interest is for delayed payment of perquisites and it is not proper to include that in the limit.
- ii. It is to be clarified whether the Rate of Interest given is the net yield (after tax) or the gross yield obtained by CIL on the investment of our corpus. If net yield has been used it will lead to double taxation as interest will be taxable in the hands of the receiver.

11. REORGANISATION OF BRANCHES AND WHATSAPP GROUPS

Convenor informed that it has become necessary to reorganise the Branches by merging some of the Branches. This will be done shortly.

Moreover, the earlier limit of 256 participants in each WhatsApp group is now enhanced to 512. The present 14 Main groups will be reorganised into 5-6 New Main groups for smooth working.

All members are advised to regularly contribute to the groups, read all the messages and visit our website **aiace.co.in** to get updates. They should also attend the meetings organised by the Branch Committees. Henceforth information will not be shared telephonically on one-to-one basis, but only on WhatsApp, website and during the meetings. Members should raise the issues in local WhatsApp group so that all members should be able to know and try to resolve at their level.
