It has been striving hard and approaching CIL, SCCL, Coal ministry and DPE regularly. It has demanded to CIL authority for formation of pay conflict resolution committee. In continuation, Sri P K Singh Rathor, Convenor, AIACE called on Coal secretary in the month of July23 and apprised him in details regarding the issue. AIACE also sought time from secretary, DPE to meet him to apprise the issue vide it's letter no. AIACE/CENTRAL/2021 / 061 dated 15.8.2023 (Copy appended below).



The secretary endorsed the letter to Sri Animesh Bharti, Economic Advisor, DPE. Sri P K Singh Rathor called on Sri Bharti on 18/8/23 in his office and put the points with logic and comparing the pay slip of workers with that of executives. He demanded that DPE being nodal deptt. of all CPSUs must intervene in the matter for ensuring justice to CIL and SCCL executives and advise coal ministry appropriately in this regard. It was informed by Sri Bharti that DPE has already sent clarification in this regard to coal ministry. MINUTES OF ANNUAL GENERAL BODY MEETING

HELD ON 26TH AUGUST, 2023

The Annual General Body Meeting of AIACE was held virtually on ZOOM platform on 26th August 2023. The agenda for the meeting was as follows:

1. Pay conflict of executives with that of non-executives post implementation of NCWA XI.
2. Enhancement of pension under CMPS 1998.
3. CPRMSE issues.
4. Discussion of annual account for CY 2022 and FY 2022-23 and adoption of the audit report.
5. Demonstration before CIL /SCCL office on 30/10/2023.
6. Issues of working executives.
7. Any other with permission of the chair.

P. K. Singh Rathor, Principal General Secretary/Convener, AIACE welcomed all the participants and requested Sri R. B. Mathur, President, AIACE to preside over the meeting. Dr B K Shrivastav anchored the proceedings of meeting.

The following points as per the agenda were discussed:

1. PAY CONFLICT OF EXECUTIVES WITH THAT OF NON-EXECUTIVES POST IMPLEMENTATION OF NCWA- XI.

The issue of Pay conflict arising after implementation of wage agreement for workers under NCWA-XI was discussed. The members resented that this agreement has violated DPE guidelines for which needs to be resolved immediately. In this connection Sri Rathor told that, immediate action has been taken by AIACE to resolve the issue. He said that representation has been made to Chairman, CIL, CMD, Singreni Collieries, Coal Secretary, DPE secretary and the coal minister. He said that he also met the Coal Secretary on 13th July 2023 and Economic Advisor, DPE on 18th August 2023 with Sri A. L. Meena and Sri Animesh Bharti respectively. Sri Rathor informed that he apprised both of them regarding the growing resentment among coal executives due to this pay conflict.

2. ENHANCEMENT OF PENSION UNDER CMPS 1998.

Feasibility of pension revision was discussed. Dr B K Shrivastav explained that enhancement can be achieved by way of re-evaluation of Pension fund by actuary by taking into consideration the reform measures introduced by introduction of voluntary welfare cess

being levied by CIL which nullified the actual deficit by end of December, 2019, and residual notional deficit can be eliminated if actuary is assured of regular inflow of welfare cess linked with per tonne of coal production. Sri Rathor informed that AIACE is working vigorously on these lines and a Dharna at Talcher (Odisha) is planned by AICPA, Talcher unit on 1st September, 2023. It will be followed by another Dharna in Chhindwara coalfield by AICPA, Betul & Chindwara branches and on 30th October, 2023 at CIL, HQ, Kolkata in which pay conflict issue will also be raised as elaborated below separately.

3. CPRMSE ISSUES.

Cashless IPD treatment and timely reimbursement of claims made under CPRMSE, are the 2 main issues from which members are suffering. Sri Rathore informed that, on the demand of AIACE, involvement of 3rd party is being examined by CIL and modalities are being worked out accordingly. Sri Rathor informed that AIACE is going to take up the issue to increase the life time limit from Rs 25 lakh to Rs 50 lakh and annual domiciliary payment from Rs 36000/- to Rs 100000/-.

4. ADOPTION OF AUDITED ANNUAL ACCOUNTS FOR THE YEAR 2022

On the request of Sri P. K. Singh Rathor, audited annual accounts for CY 2022 and FY 2022-23 were read out and explained by Dr B K Shrivastav, Vice President, AIACE. It was explained that expenses incurred by members on behalf of AIACE are in consultation with the Convenor and Vice-President after which these are reimbursed post-facto after ascertaining the reasonability of the amount.

Members unanimously agreed to adopt the audited accounts.

5. DEMONSTRATION BEFORE CIL /SCCL OFFICE ON 30/10/2023.

Sri Rathor informed that a Dharna on 30th October, 2023 at CIL, HQ, Kolkata has been planned in which pay conflict issue will also be raised. Members agreed to participate in it as per their convenience. Necessary activities will be planned after serving the notice for this to CIL management.

6. ISSUES OF WORKING EXECUTIVES.

Pay conflict issue due to recent implementation of NCWA-XI, Transfer & Posting, housing at colliery level, are some of the major points which were discussed in the meeting and it was vowed that AIACE will continue to fight for achieving justified results.

7. ANY OTHER WITH PERMISSION OF THE CHAIR.


After discussions as above, the all the members were invited to express their individual feelings/opinions/queries. Sri Rathor answered each and every query to the fullest satisfaction of one and all. Other items discussed are as follows:

- a) **Benevolent Fund Payment** - Sri P. K Singh Rathor informed that till now 15 spouses of deceased members have been paid Rs 10000/- under AIACE Benevolent Fund scheme.

- b) **Outsourcing of operation and maintenance of AIACE and AICPA website** - Sri Rathor informed that Sri M Z Ali had ceased to be a member of AIACE as of now. He was maintaining AIACE and AICPA website. Now both the websites had been transferred to Red Rhyme Consultant, NOIDA for maintenance and development after due discussion by committee formed for it. The consultant had started the work and the contract period was for 1 year, wef 1/9/23 extendable for another one year on the same rate.
- c) **Creche Old Home**- Sri Rathor informed that for Creche Old Home, the work has starts at Bilaspur, Bengaluru and Kolkata and land is being identified by members. He also that CIL has also been approached for providing land on lease basis for starting Creche Old Home.
- d) **Coal Club**- Sri P K Singh Rathor informed that Coal clubs under aegis of AIACE, have been started in Kolkata Ranchi, Patna, Varanasi, Delhi, Bilaspur, Bhopal, Nagpur and Bengaluru and attempt is being made to start at other places where AIACE members are residing. He further told that grand Savan Mahotsava has been organised in Patna, Bilaspur, Bhopal Varanasi, Ranchi, Delhi branch is organizing function on 27th August, 2023, Kolkata branch on 10th September, 2023 and Nagpur branch on 16th September, 2023. He further told that through Coal Clubs, AIACE is connecting the spouses of executives in main line activities and told that ladies are very much active and utilising their expertise though cultural activities.
- e) **Unnecessary and useless communication in AIACE groups**- Sri Rathor informed that many members are in habit of sending unnecessary, old and useless posts in AIACE groups. He advises that members must verify the things first before posting, only new suggestions be made and repetitions be strictly avoided.
- f) **Regular reading of posts coming in main WhatsApp groups and local groups to keep updated**- Sri Rathor noted that many members remain sleeping most of the times and they do not go through the posts. He said that every attempt was made to keep members informed. But some members keep on putting queries which were replied earlier.

Lastly, Sri Rathor appealed all members to rise to help each other and make AIACE a values organisation in terms of activities, commitment and loyalty.
