

A fruitful discussion was held on enhancement of CMPS-1998 pension. AIACE team was impressed with the positive approach of government officials. The meeting started with a healthy note with Smt. Barar introducing herself as a new incumbent having taken over the charge and being helped by Smt. Santosh Agrawal who, besides her other responsibilities, had been associated in CMPS-1998 pension matters. She emphasised that there existed the need for pension review and restructuring for which she would like to go in depth of the scheme since inception of pension under CMPS-1998 and reasons leading to present imbroglio and find out ways to solve it. AIACE team briefed her about these issues and informed that, in fact, Ministry of Coal had committed

to go for reforms in pension scheme as pointed out by relevant Parliamentary Accounts Committee report. AIACE team further informed all that, AIACE had been regularly highlighting these pension issues along with probable solutions and even our suggestions have been forwarded by CMPF Commissioner for examination by various bodies, BOT members, CIL and SCCL. . They agreed to involve AIACE in finding out an amicable solution to the problem. AIACE pleaded for peer review of Actuary's report by another Actuary/Consultant. There was unanimity for this demand. Joint efforts would be taken in subsequent frequent interaction of AIACE with Ministry official. Feasibility of various likely steps were discussed, which would be further explored for implementation.

Smt. Barar stated that, there is a need to go ahead with appointment of an external agency of Specialists to quickly suggest ways in consultation with AIACE and other stake holders. She agreed that interactions with AIACE will continue by holding number of structured meetings and work for pension revision based on practices in other PSUs and elsewhere. In first of such structured meetings, a meeting has been scheduled in the first week of March at Bilaspur which was confirmed by the following email :-



During the meeting at Shastri Bhawan, Smt. Barar assured us of her full support to our cause. She, then along with Sri Mishra, Commissioner, CMPFO, requested us for calling off the Dharna on 12th February in the wake of positive discussion for resolving the issue. It appeared that the Ministry of Coal was, in principle, agreeable to take needful action for revision of pension.

Sri Rathor told Smt. Barar and Sri Mishra that he alone could not take decision to postpone the Dharna and decision would have to be taken in the meeting of AIACE/AICPA and a consensus decision would be taken for proper communication.

Hence, for arriving at any consensus, Convenor Sri Rathor invited others to speak on these developments.

Sri. Abdul Kalam explained that concrete steps have been taken during the meeting and it is a big step forward. As suggested by Addl. Secretary, we can choose and put forward the best pension plans of other PSUs and also a reputed independent consultant may be engaged for actuarial valuation of the pension fund and needful reforms. Addl. Secretary has agreed to attend the meeting at Bilaspur with her team. We should invite all other organisations/unions that are pursuing revision of pension. It now appears that our long struggle for revision of pension will achieve the desired result very soon.

Dr. B. K. Shrivastav said that the terms of reference of the independent consultant/actuary are to be finalised. Any reputed consultant/actuary will not give a report in favour of one party but will base its report on facts and figures. MOC has said that they will take into consideration the views of AIACE/AICPA. He informed that 1.5% to 2% of profits can be contributed by PSUs and this could be another way of improving the status of pension fund. We are very near to achieving our goal.

Many of the members expressed their views on these developments and congratulated the leadership of AIACE/AICPA for the great achievement.

For acceptance of the House, the following motion was moved by Sri R. A. Manjunatha Prasad:-

"In view of the recent positive initiatives and assurances of Coal Ministry and CMPFO, the house resolves to postpone the proposed Dharna at Jantar-Mantar, Delhi on 12th February, 2024."

The motion was passed by voice vote.

Accordingly, it was declared to postpone the Dharna planned for 12th February 2024.

It was also decided to communicate the decision taken in the meeting to the coal minister, coal Secretary, CMPF commissioner and others.

The meeting ended with a vote of thanks by Dr. B. K. Shrivastav.


