The meeting was called to order by the President who welcomed all participants and especially Mr. PKS Rathor, Principal General Secretary - AIACE who also graced the occasion.

Joint Secretary moved the agenda, which was adopted unanimously without any changes:

- 1. Meeting called to order & Welcome by the President
- 2. Welcome & Seeking approval/alterations to Agenda by Secretary.
- 3. Item wise deliberations:

a) Decision on venue & schedule of the day on Foundation Day

The venue for the Foundation Day celebration was discussed at length; and, after considering many options, it was unanimously decided that the gathering shall be organised in Ernakulam region, depending upon the availability of a suitable venue. An idea also sprang up to explore the possibility of hiring a houseboat to organise this function. It was agreed to find out availability and viability of it. As regard to schedule for the program, it was decided that the gathering shall start with registrations and fellowship at 10 AM and the actual program will start at 11 AM and shall continue up to 4 PM. Sharing the history, activities and endeavours of the Association, personal sharing of life experiences of members, entertainment events and group games shall form the day's schedule. Welcome drink, lunch, tea and snacks will be served to the participants at appropriate intervals.

b) i) Strategy for bringing together all 36 active members

A strategy was worked out to ensure that all the 36 active members are inspired to participate in the Foundation Day celebrations along with their spouses. It was decided that the Secretary will send out to the Executive Committee members the list of members to be contacted by each and it will be more effective when more than one Executive Committee member contacts the members as an additional motivation. This exercise shall be completed by Wednesday, the 17th April 2024 and the scenario shall be reviewed in a Zoom meeting of the Executive Committee on the same day. Zoom meeting link shall be circulated by the Joint Secretary in advance.

ii) Spectrum of participation - include spouse & children?

It was decided that the members shall attend the program along with their spouses to the maximum extent possible. The ladies should be encouraged to participate in the cultural programs.

iii) Last date of confirmation by participants (including number of persons)

It was decided that we should have a tentative head count of participants by 30th April 2024 and the final figure by 7th of May 2024 so that the venue and catering arrangements can be made in advance effectively. We should also have a list of vegetarian and non-vegetarian participants.

iv) Budget of expenses and pooling resources.

As regard to financial involvement, Mr. PKS Rathor informed the house that 30% of the members' subscription amount is allocated for meeting branch expenses and over and above this if there is a deficiency in the budget, it shall be taken care of by the Central body. Our annual subscription amount for 36 members is Rs. 18,000/- and 30% of it would be Rs.5,400/- only which will not be sufficient to take care of the expenses. It was also felt that since the branch members have been contributing membership subscription during the past years and the branch has not claimed any amount before, Central body may be requested to be lenient towards its share of contribution to Kerala branch for this function.

In spite of the above, in order to raise fund for the program, every participant may be required to contribute some amount. The general opinion was that the Kerala branch is organising their first physical gathering and it should be done in a befitting manner. Hence, all the members should come forward generously to contribute to meet the expenses of the gathering. The exact amount to be contributed shall be decide in the meeting on 17th April 2024 upon making an estimate after finalising the venue etc.

c) Assigning responsibilities

Moving on to assigning responsibilities to committee members, various activities were identified which include,

- i) Venue booking
- ii) Physical arrangements at venue
- iii) Catering
- iv) Invitations, follow-up & Guest management
- v) Fund Management
- vi) PR and Media management

It was suggested that since Jt. General Secretary of the branch belongs to Ernakulam district, he may be entrusted with the responsibility of exploring different possibilities of finding a suitable venue and report to the Executive Committee for final decision. Once the venue is fixed, catering outsourcing estimate also may be worked out for final approval of the Executive Committee. Public relations and media management was emphasized and the details will be worked out along with other assignments in the next meeting. However, an advance information poster will be displayed in the group to keep the members informed of the program and to motivate them to participate in it.

There was no other matter raised for discussion in the meeting.







MINUTES OF THE MEETING ON 11TH JUNE 2024

A ZOOM Meeting of AIACE and AICPA was held on 11th June 2024 to discuss the following items on the agenda:

- 1. Fresh movement for Pension Revision
- 2. Resolution of pay conflict between executives and wage board employees
- 3. Promotion of executives
- 4. Implementation of transfer policy
- 5. CPRMS for executives and non-executives
- 6. Issue of revised PPO
- 7. Delay in start of pension on retirement
- 8. Any other matter

Sri.R.B.Mathur, President, AIACE presided over the meeting and wished all the members for the success of our agitation. He complimented Sri P.K.Singh Rathor, Convenor, AIACE for calling this meeting at an appropriate time. He advised that a delegation should meet and greet the new Minister of Coal Sri Kishan Reddy and appraise him of our problems. This meeting should take place within June 2024. He stressed that all of us have given many years' services to Coal Industry but unfortunately, we are not considered important now. We need to go ahead with our agitation for enhancement of pension and other issues.

1. Fresh movement for Pension Revision

Sri P.K.Singh Rathor, Convenor, AIACE, welcomed all the members and informed that our demonstrations at Jantar Mantar, New Delhi and at CMPF Office Dhanbad have yielded limited success in that the minimum pension has been revised to Rs.1000 per month and CMPFO has started issuing revised PPOs. However, the work is very slow and some PPOs are deliberately issued with errors. Since all the required data is available with CMPFO there is no reason for delay in completing the process. A letter has been written to Smt. Rupinder Brar, Addl. Secretary, MoC with a request to confirm holding of a workshop at Bilaspur on revision of pension and other related issues. We expect to arrange the meeting shortly. The authorities have realised that pension is our right and a revision is due. The Pension Corpus has been mismanaged by CMPFO and we have put forward several suggestions to improve its status and also demanded fixing of responsibility for the mismanagement of funds. AICPA and AIACE, Andhra/Telengana Branches are requested to come forward and obtain an appointment with Minister of Coal.

Sri Nilanjan Adhikary of Asansol Branch said that a study shows that the funds have been mismanaged and we should file a PIL to probe into this and there should be total transparency in the management of the corpus. Dr. B K Srivastav endorsed this view and said हमें न्याय नहीं, सिर्फ समाधान चाहिए. The government had assured in 2019 to take action but nothing has been done till now. If the corruption in CMPFO is stopped, pension can be enhanced. भ्रष्टाचार हटाओ और पेंशन बढ़ाओ. We should demand an investigation by CBI. Sri Arun Singh of Ranchi, Sri R A M Prasad of Bengaluru and Sri Dinkar Sahu of Betul said that we should act immediately and hold demonstration at Dhanbad. Sri D Ramachander Rao, Hyderabad said that the workshop on CMPS should be arranged at the earliest. Sri Rathor requested Sri Dinkar Sahu to meet Sri. D D Uikey, MoS, Tribal affairs representing Betul Parliamentary constituency, and try to arrange a meeting at the Ministry level. Dr. A M Mohan suggested that a report be prepared on the fund management and corruption at CMPFO and we should take legal action. Sri S N Singh, Varanasi said that we trusted the assurances given by the Government and CIL and postponed the agitation planned for 12th February 24. However, there is no progress and the time has come for stronger action to take the issues forward. Sri Pawan Tandon, Asansol suggested that we demand details of fund management and call for a Dharna at Dhanbad in 1st week of August 24.

All members present in the meeting concurred with the above suggestions.

2. Resolution of pay conflict between executives and wage board employees

Sri Rathor informed that action is being taken by CIL management as per the assurance given by Chairman, CIL. There are some issues with the Trade Unions that are being resolved. Sri P K Sharan, Bilaspur said that many executives are demoralised due to the pay disparity and it has to be resolved immediately. Sri Rathor said we will wait for another 2 months.

3. Promotion of executives

Suggestions given by AIACE for career growth of Diploma holders are under consideration by the management and DPCs are going on. Sri Nilanjan Adhikary said that instead of time-bound promotions, merit should be considered.

4. Implementation of transfer policy

Transfers are being done as per the policy and if there are any deviations, the matter will be taken up.

5. CPRMS for executives and non-executives

Recently, the medical consultation charges have been enhanced. The disparity in the ceiling amounts between executives (Rs.25 lakhs) and non-executives (Rs.8 lakhs) needs to be removed.

Sri R K Chowrasia informed that there is an inordinate delay in reimbursement of medical claims by non-executives due to the fact that the claims are to be submitted at colliery level and the process takes too long.

Sri Nilanjan Adhikary said that empanelled hospitals of Durgapur, WB have opened branches at Asansol and these branches should be empanelled. Dr. A M Mohan clarified that the hospitals should apply to CIL with all documents required for empanelment.

Sri Ravi Shankar, Bengaluru informed that Apollo Hospital, though empanelled, is denying CGHS rates for cardiac treatment saying that their bills are outstanding with CIL and other subsidiaries for a long time. He was advised to post details of his case.

6. Issue of revised PPO

CMPF staff in connivance with colliery staff are intentionally issuing faulty revised PPOs. Some of the PPOs do not have photographs of the pensioner and spouse. The progress of work is very slow. These issues will be followed up.

7. Delay in start of pension on retirement

There are many such cases and we have already written a letter to Commissioner, CMPF on this matter.

8. Any other matter

Sri Nilanjan Adhikary said that Foundation Day of AIACE is celebrated by all branches on a grand scale but many members failed to attend. He requested for steps to ensure wider participation by members. Sri P.K.Singh Rathor, Convenor, AIACE replied that a large number of members never attend any meeting, but try to gather information on a personal level by calling the office bearers and avoid any social gathering for the reasons best known to them. AIACE Branches are trying their best to bring together all members and their families by arranging meetings and to inform them about the latest developments on various issues.

Sri. R.A.Manjunath Prasad gave a summary of discussions and proposed a vote of thanks.

Sir,

We, on behalf of All India Coal Pensioners Association (AICPA) extend you our best wishes on assuming charge of Minister of Finance & Corporate Affairs.

We are an association of serving and retired coal executives and employees of Coal India Ltd and Singreni Collieries Co Ltd. We have also a sister association namely All India Association of Coal Executives (AIACE), in which executive employees of CIL and SCCL are included as members. Last, but not the least, we also have under our umbrella, the dependent spouse(s) of our deceased colleagues who are honoured in our body as Associates.

It is brought to your kind notice that many pensioners are getting less than Rs 1000/- per month in spite of working in dirty environment for long years for meeting the energy requirement of the country. Even the highest Board level and below board level executives who retired before 2007 are getting a meagre pension, insufficient to lead comfortable life.

The coal pensioners are covered under Coal Mines Pension Scheme called CMPS-1998. This scheme was notified on 31st March 1998, and presently approximately 6 lakhs pensioners are receiving pension under the scheme. For providing pension, fund is generated out of earnings from a corpus which is created out of contribution of working employees.

It is projected that gross mismanagement of Fund has led to erosion of initial corpus. In 2017, Parliamentary Accounts Committee (PAC) report had pointed out several irregularities and mismanagement of corpus fund and asked government for remedial measures and restructuring which was agreed by Government in 2019. However, it is a pity that authorities are yet to arrive at a solution and arrange for missing corpus that could have enhanced pension amount and linked it with rising inflation. This is to reiterate that, pension once fixed, has remained constant over the years in spite of provision for review of scheme every three years and for enhancement of pension.

It is apprehended that, officials at coal ministry, though convinced for pension revision are unable for an early resolution in absence of proper direction from various wings of government.

We shall be highly obliged to you for extending support to our cause and use your good office for resolving this critical issue by taking up with the coal minister as poor pensioners are on the verge of starvation with the present pension amount.

Today on 10-07-2024, Sri D Ram Chandra Rao and Sri Meduri Vijaya Babu called on Sri G Kishan Reddy, Hon'ble Minister of Coal in Hyderabad on behalf of All India Coal Pensioners Association (AICPA), Singareni Retired Employees Welfare Association and All India Association of Coal Executives(AIACE).
