Sub:--Reimbursement of medical bill at CGHS rate to Sri Hejamadi Sreekanthan for treatment in CIL non-empanelled Hospitals at Mysore,Karnataka.

Dear sir,

Sri Hejamadi Sreekanthan retired as Addl Chief Engineer, C M P D IL in 1995 and at present is residing in Mysore, Karnataka. He sent two bills of his treatment for an amount of *for Rs96706.25 for expenses incurred at the B G S Apollo Hospital at Mysore and the other at the Sigma Hospital at Mysore for an amount of Rs 36832.00. The bills had been curtailed and he received only Rs 22785.00 and Rs 10431.00 respectively.* . These two bills were in accordance with the latest *circular No.C I L /C-5A(PC)CPRMSE/2005 DATED01.04.2017* of coal India which states that in cities where C I L empanelled Hospitals are not available, the ex-employees can claim C G H S rates for reimbursements, at Hospitals which are approved for empanelment by any of the other PSUs or state government departments etc. But the bills were approved for reimbursement as per M A R rates..

B G S Apollo Hospital is not empanelled by CIL but is in the empanelled list of other PSUs and state Govt. *including Bharat Earth Movers Ltd, Central Food Technological Research Institute, Power Grid Corporation Of India, Reserve bank Of India, State bank Of India etc. Similarly, SIGMA HOSPITALS, MYSORE is in an approved hospital by the State Government , by District AYAUSH officer, Zilla Panchayat, I. M. A, as well as for the State Government's YASHASWINI scheme, besides being an approved Hospital for Surgical gastroenterology & ONCOLOGY.*

In the light of above facts, it is requested to direct concerned personnel executives and doctors to review the bills claimed by Sri Hejamadi Sreekanthan and pay the difference amount as per CGHS rate.
