Dear Sir,

Late Mr. Rajinder Paul Trehan retired from services in the year 2001 and was staying in Sarita vihar, New Delhi.He was not keeping well due to some breathing trouble and was diagnosed by TB in mid of April 2018. He was undergoing treatment for the same and was at home only till 27th April.

On 28th April , suddenly he got fainted at home and was taken to Holy Family Hospital, New Friends colony, New Delhi in emergency around 10 pm. In hospital, when doctors diagnosed his case, they found him with low BP, breathlessness and severe water accumulation on his left lungs. He was immediately put into ventilators. Further to his health condition ,there were certain other complications too. Ultimately he died on 7/5/2018.

Mrs Santosh Trehan w/o late Trehan had applied for the reimbursement for medical expenses of late Rajinder Paul Trehan which was forwarded by Mrs Neela Prasad , Chief Manger(P),CIL Delhi office to Dr D Paul , Medical Superintendent, CIL, Rajarhat, , Kolkata vide the letter no.CIL/DELHI/2018/642 dated 16/5/2018.

Though, CPRMSE does not provide for reimbursement for treatment in non-empanelled hospitals. However, in case of, emergency like heart attack or road accidents, if treated in non-empanelled hospitals, reimbursement as per ceiling rate of Medical Attendance Rules of Coal India Limited may be considered after approval of competent authority.

It is brought to your kind notice that no reimbursement has been made to Mrs Trehan till date and she is in acute financial crisis. It is requested to direct concerned officials for clearing the bills and making payment at the earliest.
