AIACE has been raising the issues of incomplete NPS data of executives from time to time. But it is sorry to inform that our representations perhaps remained unattended leading to great resentment among retired executives towards CIL mgt. It is informed that AIACE has always stood with mgt and has counselled it's members from time to time on the issue of NPS.

Our members are very much agitated over the delay in implementation and also on incomplete data. The arrogance of dealing executives and staffs and their apathy towards resolving the issues, at corporate level at CIL and subsidiary Hqs has created the impression that mgt does not worry for retired executives. Although, nodal officers for subsidiary companies have been designated, they do not pick up call and also they are not fully equipped to resolve the issues. So, the ball throwing game is going on from area to company HQ and to CIL HQ and vice-versa. For reference, I am giving some of the cases which need immediate attention.
