SUB: Enhancement of Pension due to pay revision wef 1/1/2017.

Pursuant to the revision of pay scales of executives of Coal India Ltd. with effect from 1st January 2017, the pension amount payable to executives superannuated after that date under Coal Mines Pension Scheme, 1998 was to be enhanced according to the new pay scales. However many executives, who retired after 1-1-2017 but before the implementation of the revised pay scales, continue to receive pension at the old rates. One of the probable reasons for this may be that their revised data and contribution has not been sent to CMPF office by the units. But in some of the cases revised pension has not been released even after this data and contribution have been sent by the Coal Companies.

Since the financial implication of this is quite considerable from the point of view of the retired executives, many such affected members of AIACE have represented to us to take up this issue with concerned authorities.

We are enclosing a detailed list of 97 such cases for your kind information and request you to take necessary action so that the retired executives can get pension at revised rates and also the arrears of pension at the earliest. A few more cases are under verification and will be forwarded to you shortly.
