Please refer to our letter no. Secondly, it is observed that LIC and some other Annuity providers have not yet started payment of enhanced proceeds resulting out of enhanced addition to Corpus fund of executives whose salary got increased due to pay scale revision w.e.f. 1.1.2017. It is requested to advise the failing annuity providers to speed up their process soon.
