**Sub: Failure of CMPFO in regularizing Enhancement of Pension under CMPS-1998 due to pay revision w.e.f. 1.1.2017**

Respected Sir,

Pension for coal employees in CIL/SCCL is computed based on the average salary of the last 10 months and the period of pensionable service. The average salary, and hence the pension, will increase if pay is revised upward.

The pay revision of CIL/SCCL executives with effect from 1st January 2017 was subject to delayed implementation from the month of October 2018. Many executives who retired in this intervening period of 1-1-2017 to 30-09-2018 are accordingly entitled to higher Pension under CMPS-1998 at the revised average salary. Although, CIL & SCCL have paid arrear arising due to this revision, many of the executives are still awaiting revised pension from CMPFO.

All India Association of Coal Executives (AIACE) has made several representations to the Commissioner, CMPFO, Dhanbad for revising the pension based on revised salary. The copies of our correspondences are enclosed for your ready reference. We even offered the services of our experienced and knowledgeable members to help CMPFO to clear the backlog of cases.

In spite of our continuous follow-up over the past one year, there are many cases yet to be settled. We are hereby enclosing the list of 67 cases pending enhancement of pension.

The apathy and inefficiency of Coal Mines Provident Fund Organisation towards the legitimate claim of the pensioners and suspected malpractices prevailing there which are causing great resentment among coal employees towards the coal ministry and central government in spite of your hard work for improving the efficiency in the system.

We humbly request you to intervene in this matter and direct CMPFO to initiate steps for immediately clearing all such cases, including the referred 67 cases herewith, and release the arrears of pension along with interest. We also request you that Chairman, CIL, Kolkata and CMD, SCCL, Kothagudem may be advised to instruct all the concerned officials for needful liaison with CMPFO and follow-up the cases in order to ensure justice to the coal employees who have rendered decades of dedicated service to the coal sector.

Pursuant to the revision of pay scales of executives of Coal India Ltd. with effect from 1<sup>st</sup> January 2017, the pension amount payable to executives superannuated after that date under Coal Mines Pension Scheme, 1998 was to be enhanced according to the new pay scales. However many executives, who retired after 1-1-2017 but before the implementation of the revised pay scales, continue to receive pension at the old rates. One of the probable reasons for this may be that their revised data and contribution has not been sent to CMPF office by the units. But in some of the cases revised pension has not been released even after this data and contribution have been sent by the Coal Companies.

Since the financial implication of this is quite considerable from the point of view of the retired executives, many such affected members of AIACE have represented to us to take up this issue with concerned authorities.

We are enclosing a detailed list of 97 such cases for your kind information and request you to take necessary action so that the retired executives can get pension at revised rates and also the arrears of pension at the earliest. A few more cases are under verification and will be forwarded to you shortly.

Dear Sir,

Kindly refer to our earlier letters no. 2020\_032 dated 1<sup>st</sup> April 2020 and no. 2020\_039 dated 25<sup>th</sup> April 2020, along with enclosures containing list of executives who retired after 1/1/2017. Pursuant to the revision of pay scales of executives of Coal India Ltd. with effect from 1st January 2017, the pension amount payable to executives superannuated after that date under Coal Mines Pension Scheme, 1998 was to be enhanced according to the new pay scales which were implemented in 2018.

However many executives, who retired after 1-1-2017, but before the implementation of the revised pay scales, are deprived of enhanced pension admissible under new pay scales. They continue to receive pension at the old rates. One of the probable reasons for this may be that their revised data and contribution might not have been sent to CMPF office by the units. But in some of the cases revised pension has not been released even after this data and contribution sent by the Coal Companies. On last 2 occasions ,we had submitted list of our such members out of which many are yet to get revised pension.

Since the financial implication of this is quite considerable from the point of view of the retired executives, many such affected members of AIACE have represented to us to take up this issue with concerned authorities.

Under the circumstances, we request immediate resolution of the issue.
