Sub: Empanelment of new hospitals (Yatharth Hospital, Greater Noida and Begal Faith Hospital, Burdwan) and publication of updated authentic details about already empanelled hospitals with Coal India Ltd. along with need to allow treatment in non-empanelled hospitals, as allowed by Insurance companies

Dear Sir,

We are thankful to Coal India Ltd for providing medical facilities to all it working and retired executives/ employees and their eligible dependents. Apart from existing hospitals being run by the company,, more than 300 private hospitals across the country have also been empanelled by CIL. The company has also made provisions to avail treatment at various hospitals which are either government-owned or empanelled with other PSUs.

It is a matter of satisfaction that the list of hospitals empanelled with CIL is being revised regularly. In this calendar year also, the list has been revised twice on 17.2.2021 and 12.6.2021.

Through this letter, we wish to highlight the issues related to empanelment of hospitals and the need to allow treatment in non-empanelled hospitals as allowed by Insurance companies which are the preferred agencies of DPE for implementation of post-retirement medical care of executives belonging to CPSEs.

Issues associated with empanelment of hospitals

It is to bring to your kind notice that, due to different reasons, some of the empanelled hospitals are denying cashless facilities and are even unwilling to extend CGHS rates to working and retired executives/employees. Some of these hospitals even deny that they are empanelled with CIL and maintain that empanelment, if any with CIL is no more valid now.

At the same time, new willing hospitals are coming forward for empanelment as per laid down procedure of CIL circulated vide office order no. CIL/C-5B/Med/2017-18/018/481(A) dt 23-6-2017.

Recently, on 26th April, 2021, **Bengal Faith Hospital, Burdwan** has submitted application for empanelment with CIL and have endorsed us a copy vide Annexure-A. The medical deptt has not included this hospital in the latest list of Empanelled Hospitals published by CIL on 12th June 2021.

Similarly, on 3rd February, 2021, **Yatharth Hospital, Greater Noida (Delhi-NCR)** applied for empanelment and this hospital has also met with the same fate. In this case, we had even communicated about this

Hospital to CMS, CIL for empanelment of this hospital vide our letter no. AIACE/CENTRAL/2021/021 dt 25.2.2021 (Copy enclosed in Annexure-B), but no further development is known to us.

It is irony that in the present situation where willing hospitals are rarely coming forward for empanelment, the system at CIL is so morbid that it even fails to respond to these hospitals applying for empanelment. No hospital is empanelled at several places where sizable number of retired executives/employees are residing and are facing harassment.

It is also brought to your kind knowledge about un- updated information about some of the empanelled hospitals. There are instances that after initial empanelment, some hospitals have changed their names/contact numbers/email details etc. Sometimes their managements have also changed but the medical department fails to take cognizance of these changes and fails to update the list. This is causing harassment to the retired executives/employees who go for treatment after verifying the names of empanelled hospitals as per circulated list.

In the above regard, burning example is the case of our member Sri J S Mathur (EIS no. 90113440), whose claim remained unsettled for months because the hospital shown as Narayana Hrudayala Hospital, Sector-28, Kumbha Marg, Sanganer, Jaipur-302033 has changed to Narayana Multispeciality Hospital (A unit of Narayana Hrudayala Ltd.) since 2017. All concerned with his bill settlement were not ready to recognize the new name in spite of submission of all relevant papers, including Income Tax clearances by the hospital. The member as well as the hospital had a very distasteful experience of workings at CIL. There are many other such cases. In spite of several representations/correspondences by Mr Mathur and the hospital itself, new name of hospital has still not been entered at Sl. No. 141 of the latest revised list dated 12th June 2021. In this context, there are other similar irregularities in this latest list as shown in subsequent paragraphs.

Examples of hospitals at Bhubaneswar and Ahmedabad are given below.

A. Bhubaneswar:-

The hospital at SI. No. 29, LV PRASAD EYE INSTITUTE refuses treatment for Coal India employees on CGHS rates .It charges Rs 150 for one eye test and Rs 350/ for both eyes. A layman knows that, under normal circumstances the eye specialist is duty bound to examine and prescribe medicines for both eyes.

At SN 39 -- Sunsine hospital is there which has been closed since 2019. This hospital is being managed by new staffs and doctors and does not allow OPD treatment to COAL INDIA employees.

At No 40, Aditya care Hospital is there which has been taken over now by Aditya Ashwine hospital, Cuttack The name of the hospital has been changed and new name Aditya Ashwine Hospital doesn't find place in the latest list.

B. Ahmedabad:-

At SI. No. 1 – Shalby hospital, Ahmedabad, is the very first hospital in the latest list of empanelled hospitals. This hospital refuses to recognise any empanelment with Coal India. There are other hospitals, who also claim that they are not now under empanelment with CIL.

From the above, it is understood that concerned department publishes the list of hospitals without entering/renewing empanelment contract with these hospitals. When executive /employees get treatment

in these hospitals, they have to pay hefty charges as per bills raised.

AIACE expects favourable streamlining of decision making process at CIL for empanelment. The role of CIL Medical department should not be limited to only adding hospitals arbitrarily, but to add judiciously

expeditiously maintaining transparency while entering into fresh agreement with hospitals.

We, in the good interest of retired employee also request to empanel Bengal Faith Hospital, Burdwan and

Yatharth hospital, NOIDA, if they fulfil the criteria laid by CIL.

Need to allow treatment in non-empanelled hospitals

Finally, when we are talking of treatment at empanelled hospitals and various constraints involved in it, it

will be worthwhile to revisit the DPE guidelines circulated vide No. 2(81)/08-DPE(WC)GL-XV/2011 dated 20th

July, 2011 (attached herewith as Annexure-C). Underlined in red, in this guideline, under Section 2(v), DPE has suggested that post-retirement medicare scheme be preferably implemented through Insurance

companies. CIL preferred to have its own scheme but has failed to incorporate the most appreciable feature

of Insurance companies through which they allow treatment in any non-empanelled hospital at CGHS rate.

We feel that, CIL must now add this feature in its own scheme by suitable amendments.

It is further requested to allow treatment in any hospital nearer to the place of residence which are willing to

extend CGHS rates and reimbursement of bills thereof to the executive s/employees.

It is suggested that CIL may undertake mandatory yearly inspection of hospitals by a high power committee

of executives in order to make the hospitals responsible as well as accountable to CIL for fair service.

OFFICE MEMORANDUM

Sub: Creation of Corpus for retired employees of CPSEs

The undersigned is directed to refer to O.M. of even number dated 8.07.2009 on the subject mentioned above providing Board of Directors of each CPSE to frame a suitable scheme keeping in view the guidelines contained in the aforesaid O.M., based on their need and affordability and submit proposal to the Administrative Ministry/Department for approval. Subsequent to issue of O.M. dated 08.07.2009, a number of representations have been received in this Department, requesting for modifications in the Scheme. Government has accordingly reviewed the efficacy of the scheme as conveyed in O.M. of even number dated 08.07.2009.

- 2. In view of the above, the following has been decided:
- i) Administrative Ministry/Department may consider creating a common corpus for the retired employees of the CPSEs, under their Administrative control. The purpose of the corpus would be to take care of medical and any other emergency needs of retired employees.
- ii) Each CPSE under the Administrative Ministry/ Department, to contribute not more than 1.5% of its PBT for the above said corpus.
- iii) A Committee, headed by an Independent Director, to be decided by Ministry/Department may be formed by the respective administrative Ministry/Department for implementation of said corpus.
- iv) Scheme based on individual CPSE as conveyed in O.M. dated 08.07.2009 to continue but basic conditions like not more than 1.5% PBT (whether Ministry/Department based and/or individual CPSE based) and no budgetary support by Government would apply to the Ministry/Department based scheme proposed now. Therefore, there may be a situation, where a CPSE under a Ministry/Department may have a separate scheme for its retired employees,

but at the same time contribute to common corpus for retired employees of other CPSE(s) under Administrative Ministry/Department. In such cases also the total contribution will not exceed 1.5% of PBT of a particular financial year. For individual CPSE based scheme, constitution of Committee will be that as already indicated in para 5(iii) of O.M. dated 08.02.2009.

- v) Purpose of the scheme (Individual or Common corpus under a Ministry/ Department for its CPSEs) to be as per from 2(i) above. The scheme may be implemented preferably through approved Insurance Companies. It is clarified that scheme should not become a defined benefit pensionary scheme.
- vi) The benefits under the Scheme may vary from year to year depending upon the contribution by CPSE(s) in a particular year as the contribution is in turn dependent on the Profits, affordability and sustainability of the CPSE(s) concerned.
- vii) The issue of 'emergency needs' may be decided based on the principles of fairness, transparency, functional requirement, affordability sectoral similarities and sustainability of the common corpus, etc., with the prior approval of the aforesaid Committee.
- viii) Such corpus will cover only those employees of CPSEs, who retired prior to 01.01.2007.
- 3. Administrative Ministries/Departments may suitably issue instructions to the CPSEs under their administrative control for their information and necessary action.
