Sub: Follow-up on our Intimation regarding **Fast unto Death** on 15th Aug., 2021 announced by Sri H. K. Chaudhury, EIS No. 90009986; CMPF No. S235280; PPO No. 100009100 for Re-fixation of Pension and payment of arrear with interest

Dear Sir,

Kindly refer to our earlier no. AIACE/CENTRAL/2021/070 dt 17-6-2021 by which we had drawn your urgent attention to the injustice done to its member, Sri H K Choudhury on the above subject. Sri H. K. Choudhury, EIS No. 90009986; CMPF No. S/2/35/280; PPO No. 100009100, had retired as Project Officer, Rajahara Area, CCL on 30/11/2006.

In this connection, we have in our possession a letter from Region-I, CMPFO to GM, Rajhara Area, CCL vide Letter no. CPF/16/PF/RAN/26/R-I/2020-21/8-10/660-662 dt 25-6-2021. (Copy enclosed in Annexure-I). By this letter, again a confirmation is being sought as when the PF contribution for the period 3/73 to 3/76 was deposited along with PF contribution for 3/85.

We feel that copies of all the relevant information have been duly submitted with the representation of Sri Choudhury and these can be physically verified by concerned office of CMPF at the respective colliery/area offices. For CMPFO, it is a regular practice to verify/audit records in collieries and adopting this method will not mean any deviation from established practices. It will rather solve the problem expeditiously because resorting to letter writings will only exaggerate the problem. By the time a person sitting on a particular desk is familiar with the case, he/she will be transferred and some other person will be assigned the task who will again start a fresh.

For convenience, we are again briefly explaining his case and enclosing 4 important Annexures, justifying his claim.

- a. Pension of Sri H K Choudhury (CMPF no –S/2/35/280) has been fixed at Rs 8895/ considering his length of service since June.1976. Unfortunately, erroneously his length of service as JME since 1/8/1973 was not considered. Later on this anomaly was rectified and his service was regularized since 1/8/1973 vide office order no ECL/C-5(D)/M-1258/18010 dated 10/5/1982 (Copy vide Annexure-II)
- b. Pay of Sri H K Choudhury was re-fixed and communicated by Dy. FM (Establishment), ECL vide letter no ECL/ACCOUNTS/PAY FIXATION/52/GENL/3068 dated 15/12/82 (Copy vide Annexure-III)
- c. Recalculation of Pension and CMPF dues has been certified by Sr. Manager (Collieries), Nimcha Colliery, Satgram area, ECL vide his letter no. NIM/AGT/PD/2017/2407 dt 21-8-2017 (Copy vide Annexure-IV).
- d. The above letter also enclosed VV Statement showing Statement of reckonable months with month wise details. It also mentions under N.B. **The total PF deduction of Rs 4892.08 in 03/85 includes also from arrear payment made during 01/08/1973 to 03/76 as per records.** (Copy vide Annexure-V).

Hence, instead of buying time and lingering over the issue, it is requested to resolve the issue before some tragedy does occur by deputing an empowered high power dedicated team, with decision making authority, to visit various colliery offices and have appropriate liasioning to arrive at an amicable solution.

उपर्युक्त सदरित पत्रांक द्वारा उक्त सदस्य का पेंशन से संबंधित शिकायत पत्र प्राप्त हुआ। सदस्य ने इस विषय पर सीपीग्राम में भी शिकायत दर्ज की है। प्राप्त प्रपत्रों के परीक्षण उपरान्त श्री चौधरी का पेंशन निर्धारण सही प्रतीत होता है। इस विषय पर निमचा कोलियरी से प्राप्त प्रपत्र (प्रति संलग्न) का अवलोकन करे जिसमें उन्होंने 3/85 के भविष्य निधि अंशदान में एरियर भविष्य निधि राशि के सम्मिलित होने का उल्लेख किया है किन्तु एरियर किस वर्ष से संबंधित है इसकी पुष्टि नहीं है। पुनः 3/85 में एरियर अंशदान में पेंशन अंशदान की राशि नहीं है जिससे पुष्टि होती है, कि उक्त एरियर 3/73 से 3/76 की अवधि की नहीं है। साथ ही ज्ञात हो कोयला खान पेंशन स्कीम के अर्न्तगत पेशनेबुल सर्विस की गणना नियुक्ति तिथि के आधार पर न होकर वास्तविक महीनों की संख्या जिसमें पेंशन अंशदान की कटौती की गई हो, के आधार पर होती है।

अतः इस विषय पर इस कार्यालय से प्रेषित पत्रांक CPF/16/RAN/26/R-1/17-19/307-309 दिनांक 11.05.2018 के अनुसार विवरण उपलब्ध करायें सम्बंधित क्षेत्रीय कार्यालय से प्राप्त विवरण के अनुसार उक्त अवधि में अंशदान नहीं है। साथ ही अगर 3/85 में जमा अंशदान में संबंधित अवधि का भविष्य निधि अंशदान है, तो उक्त अवधि का पेंशन अंशदान कब जमा किया गया है, बताए। पुष्टि हेतु सम्बंधित अवधि का Due वेतन/अंशदान एवं Drawn वेतन/अंशदान का विवरण उपलब्ध कराए।
