Respected Sir,

All India Association of Coal Executives (AIACE) is a unique association of working & retired Executives as well as wives of deceased executives belonging to Coal India Ltd. (CIL) and Singareni Collieries Company Ltd. (SCCL).

We do hereby approach you for your urgent intervention towards the injustice done to its member, Sri H K Choudhury. He retired from CCL (a subsidiary of Coal India Ltd.) in 2006 prior to which he had also served in ECL which is another subsidiary of Coal India Ltd.

The prevailing system for his pension fixation required proper interaction between the 2 subsidiaries of CIL as well as various Regional offices of Coal Mines Provident Fund Organization (CMPFO). Although all these bodies function under your ministry, unfortunately, they failed to properly consider his length of service in ECL for the period 1/8/1973 to!/6/1976. This shorter length of service considered has resulted in his pension fixation at a lesser amount.

Later on this anomaly was rectified and the pay of Sri H K Choudhury was re-fixed and communicated by Dy. FM (Establishment), ECL vide letter no ECL/ACCOUNTS/PAY FIXATION/52/GENL/3068 dated 15/12/82. Accordingly, Rs 4892.08 as CMPF contribution was deposited year ending 3/85 against Rs 2318.80 against actual for year ending 3/84. He has been raising the issue with Regional Commissioner, CMPF, Ranchi but his grievance has not been resolved till date. In last 15 years, Sri Choudhury might have written 500-700 letters to various institutions, but of no avail.

As such, he has been compelled to go for **FAST UNTO DEATH** on 16th Aug., 2021 for settlement of his pension pending in an unusual manner for last 15 years.

He, being a member of AIACE, had brought this matter in our light as early as 2018. Even our association AIACE had also approached all concerned officials, including Secretary, Coal, but the desired result is yet to be achieved.

We feel that Sri Choudhury has been harassed to such a level that he is left with no other option but to die before CMPFO, Dhanbad office if his pension is not revised. It is to be informed that if Sri Choudhury sits on fast unto death, in his support, other members of AIACE are planning to sit with him till realisation of the demand.

Your kind intervention in the above matter is solicited as all the relevant organizations are directly under your purview of jurisdiction.

The recent communication by ECL to CCL in this regard is attached as Annexure-I. Our self explanatory letter to Secy, Coal in this regard is attached as Annexure-II for ready reference.

Please refer to letter No. GM(RA)/PD-CMPF/Pension/2021/598 dt. 05.07.2021 of Staff Office(P&A), Rajhara Area of CCL addressed to you and to the undersigned mentioning the observation of Additional CMPF Commissioner. R-I, Ranchi for disposal of the disputes raised by Sri H.K. Chaudhari, in this regard, this is to bring to your notice that earlier vide our multiple correspondences dated 12.01.2021, 06.03.2021 & 11.06.2021, we have sent all relevant documents supplied by Satgram Area for your perusal.

It is not understood whether the same was conveyed to Rajhara Area or not, because explanation of the observation of CMPFO as mentioned in the above noted letters, are clearly evident from the said letters supported by documents.

However, we are once again sending those documents for your perusal through email since mail addressed & Staff Office(P&A) of Rajhara Area, CCL has not been mentioned in that letter, followed by hard copy explaining the observation of CMPFO. Point-wise as applicable for Nimcha Colliery, Satgram Area, ECL.

Point No.(2) As per reckonable months details provided by Nimcha Colliery, it has been pointed out that after re-fixation of salary of Sri Chaudhari in CPE-03/85, an excess amount was deposited to CMPFO for the purpose of PF & FP for the period of 3/74 to 3/76, which was sup ported by the letter of APM, Satgram Area.

Point No.(3) In the letter of APM, Satgram Area it was clearly mentioned that since from 01.08.73 (that is the date of appointment as confirmed by Form "B" which was also attached) Sri Chaudhari got lump sum amount as salary and hence his PF & Pension was not deposited up to CPE-03/76. Further since his date of appointment is 01.08.73, question of contribution of 3/73 does not arise.

Point No. (5&6) The office order of his confirmation is attached along with his re-fixation and payment of arrear after adjusting the lump sum amount as salary drawn by him from 01.08.73 to 3/76 is attached and it has been confirmed by PM. Nimcha Colliery that the excess amount deposited in 3/85 relates to the PF&FP contribution for the period of 3/74 to 3/76.

Further, telephone conversation with Mr. A Kumar, Dealing Person at CCL HQ as given by you was held about 20/25 days back and he has confirmed that the documents submitted by ECL were sufficient to explain the matter for the period he was posted at Benali and Nimcha Colliery which was also communicated to you through mail. Considering the importance of disposal of the matter in the light of information given by Sri Chaudhari for fast upto death from 15th August 2021 before Commissioner, CMPFO, you are requested to intervene into this matter with Rajhara Area, CCL along with the documents once again submitted to your for immediately disposal of the case.

Dear Sir,

AIACE wants to draw your urgent attention to the injustice done to its member, Sri H K Choudhury. He has been compelled to go for **FAST UNTO DEATH** on 16th Aug., 2021 for settlement of his pension pending in an unusual manner for last 15 years.

Pension of Sri H K Choudhury (CMPF no –S/2/35/280) has been fixed at Rs 8895/ considering his length of service since June.1976. Unfortunately, erroneously his length of service as JME since 1/8/1973 was not considered. Later on this anomaly was rectified and the pay of Sri H K Choudhury was re-fixed and communicated by Dy. FM (Establishment), ECL vide letter no ECL/ACCOUNTS/PAY FIXATION/52/GENL/3068 dated 15/12/82 in compliance of office order no ECL/C-5(D)/M-1258/18010 dated 10/5/1982. His service was regularized since 1/8/1973. Accordingly, Rs 4892.08 as CMPF contribution was deposited year ending 3/85 against Rs 2318.80 against actual for year ending 3/84. He has been raising the issue with Regional Commissioner, CMPF, Ranchi but his grievance has not been resolved till date.

He, being a member of AIACE, had brought this matter in our light as early as 2018. He is being paid lesser pension due to wrong calculation of his length of service. His case required liasioning between different organizations viz., ECL & CCL - the two subsidiaries of Coal India and Regional Offices of CMPFO at Asansol & Ranchi.

We feel that Sri Choudhury has been harassed to such a level that he is left with no other option but to die before CMPFO, Dhanbad office if his pension is not revised. It is to be informed that if Sri Choudhury sits on fast unto death, in his support, other members of AIACE are planning to sit with him till realisation of the demand.

Your kind intervention in the above matter is solicited as all the relevant organizations are directly under your purview of jurisdiction. Moreover, you are also Chairman of the Trustee Board of CMPFO. It is requested to resolve the issue before some tragedy does occur.
