Sub: <u>Postponement of Fast unto Death from 16th Aug., 2021</u> by Sri H. K. Chaudhury, subsequent to the meeting held on 13-8-2021 with CMPF Commissioner

Dear Sir,

Kindly refer to your letter no. CPF/CP/111(26)/Pen/RAN-I/Vol-III/435 dated 11th August, 2021 addressed to our member, Sri H K Choudhury.

Sri Choudhary has informed us that, in response to the above letter, he reached Dhanbad and had a fruitful meeting in conducive atmosphere on 13-8-2021, in which officials from ECL and CCL also participated. It has also been informed that Dr B K Shrivastav participated on behalf of AIACE to assist Sri Choudhury in the meeting.

Now, Sri Choudhury has communicated us that the date of his appointment has been established to be from 1-8-1973 from the records produced by the concerned company.

He is also satisfied that although the issue of his contribution @Rs 19 per month from 1-8-1973 could not be concluded in a definite way, you proposed to seek approval from CMPF Trusty Board for deposit/collection of the said amount in a fresh manner. AIACE is also happy to note that more such similar cases which were stated to be pending with CMPFO will also get settled as per Board's fresh directions.

Under the above stated circumstances, Sri Choudhury has communicated us to postpone his Fast unto Death agitation till the abiding decision of Trusty Board is received.

We are also thankful to you for informally discussing with us about the sustainability of CMPF pension fund and feasibility of incorporating DA component in pension fund. We took the opportunity to request you for sending reminders to coal companies whose comments were invited by CMPFO based on our earlier suggestions submitted on 9th March, 2021.

Accordingly, AIACE withdraws its decision of agitation in his support and wish to inform that Sri H K Choudhary is not going to sit on fast unto death WEF 16/8/2021.
