Sub: Need for Revised Audit Report showing Additional component of Interest payable to CMPF subscribers for the years 2018-19, 19-20 & 20-21 in spite of office orders

Dear Sir,

Kindly refer to our earlier letter to you vide letter no. AIACE/CENTRAL/2022/003 dt. 13th January, 2022 whereby you were informed about non-implementation of the two office orders issued by you, copies of which are enclosed in Annexures I & II.

Through these letters dated 8th January 2021 and 17th December, 2021 you were kind enough to allow crediting of additional component of rate of interest payable to the CMPF subscribers for the years 2018-19, F.Y. 2019-20 & 2020-21 were allowed for crediting.

Through various interactions with you, we had been assured that appropriate modalities will be soon notified for crediting the arrears of Interest soon specially for these retirees who are loser by way of gaining less amount in PF settlement due to this variation in interest.

However, it is regretted that our requests have fallen in deaf ears and no progress is seen in this regard. We are enclosing a sample copy of 2020-21 contribution by a CMPF Member, provided by SECL to every CMPF subscriber which is based on Audited report as provided by CMPFO. The balance as on 31.3.2021 does not reflect the additionally enhanced component of Interest.

Since the financial implication of this is quite considerable from the point of view of the working as well as retired executives, we request you for initiating corrective measures at the earliest so that the true balance as on 31.3.2022 is reflected in the next audit report of CMPF.


