Dear Sir,

Kindly refer to your letter no. CPF/CP/111(26)/Pen/RAN-I/Vol-III/423 dated 10th August, 2021 addressed to CMD, ECL and CMD, CCL in respect of Refixation of pension in respect of Sri H. K. Choudhury, Retd. GM, CMPF A/c no. S/2/35/280 of Rajhara Area, CCL. (Copy enclosed vide Annexure-I).

In this connection, a meeting was held with you in your office on 13-8-2021 in which Sri Choudhury along with representative of AIACE had participated. The meeting had inferred that the date of his appointment has been established to be from 1-8-1973 from the records produced by the concerned company.

However, the issue of his contribution @Rs 19 per month from 1-8-1973 could not be concluded in a definite way, and in view of more such similar cases stated to be pending with CMPFO, your good offices had proposed to seek approval from CMPF Trusty Board for deposit/collection of the said amount in a fresh manner.

After a lapse of more than 7 months, neither Mr Choudhury, nor we at AIACE, are yet aware of any further developments as regards to your seeking Board's fresh directions and implementation of decisions so far.

Under the above stated circumstances, Sri Choudhury is again contemplating next phase of agitation unless something positive is heard from your end.

With reference to above, this office has received a letter from Shri P.K. Singh Rathor, Principal General Secretary, AIACE intimating therein fast unto death by shri H.K. Chaudhury on 16.08.2021 before CMPFO, Dhanbad.


As per records submitted by Colliery management the date of appointment of Shri Choudhury was 01.06.1976 whereas Shri Choudhury is claiming his date of appointment as 01.08.1973 and accordingly claimed for re-fixation of his pension. The pension claim of Shri Choudhury was settled as per records submitted by colliery taking date of appointment as 01.06.1976.

The CMPS, 1998 is a contributory pension scheme and accordingly the pension has rightly been settled as per pension contribution /pensionable service furnished by the management. Shri Choudhury has claimed for re-fixation of his pension taking date of appointment as 01.08.1973 for which no conclusive document has been furnished except an increase in provident fund contribution in the year 1984 claiming the increase due to contribution for the period 01.08.1973 to 01.06.1976. However, there is no increase in pension contribution during 1984 wherefrom it can be ascertained that the pension contribution for 3/74 to 3/76 was deposited.

To ascertain the actual pensionable service/pension contribution colliery management has already been asked to furnish the details of due salary/contribution and drawn salary/contribution for the period under reference.

You are requested to intervene and concerned official may be directed to furnish the details so that actual pensionable service may be ascertained and pension of Shri Choudhury may be re-fixed.
