Sub: - Submission of Life Certificate under CPRMSE for continuation of Medical Benefits

Dear Sir,

The retired employees of Coal India Ltd. and its subsidiaries are required to submit a Life Certificate every year in November/December to avail all types of medical benefits, including fixed amount for Outdoor/Domiciliary Treatment under CPRMSE. As per letter No. Ref No: CIL/C-5C/55125/2021/2081 dated 05-07-2021 issued by Dy. GM(P/Welfare), CIL, the beneficiaries have the option to submit the Life Certificate in hard copy of revised format or generate Digital Life Certificate (Jeevan Pramaan). (vide Annexure-I)

Due to the prevailing COVID situation and advanced age of many of its members obtaining the signature of the Bank Manager was very inconvenient. All India Association of Coal Executives, as a part of its initiative to help retired executives, had made arrangements to generate Jeevan Pramaan for its members for the purpose of Pension as well as CPRMSE as per the guidelines issued by CIL. So far, we have not faced any issue regarding continuation of Pension from CMPFO.

We generated Digital Life Certificates (DLCs) for our members in November 2021. However, these members have so far not received the amount for Outdoor/Domiciliary Treatment and upon enquiry with some of the Subsidiaries, they have been asked to submit hard copy of Life Certificate in revised format in spite of the fact that they have the option to submit DLC electronically. This is a retrograde step by the Subsidiaries and will cause hardship to the retired employees.

We request you to kindly instruct all the Subsidiaries to accept Digital Life Certificate (Jeevan Pramaan) for the purpose of CPRMSE to alleviate the hardship to retired employees.
