Dear Sir,

Sri Anand Mohan Gupta, EIS No. 90075128, CMPF A/c no. DHN/40/1989, retired from the service of SECL, Korba area on 31-12-2020.

Since then, he is struggling day and night for obtaining his PF dues and Pension which have not been settled so far because of missing entries in his CMPF passbook for the financial years ending 3/91, 3/92/, 3/93 (3 months), 3/98, 3/99, 3/2000, 3/2001, 3/2002, 3/2003, 3/2005 (part), 3/2009 (part), 3/2013 (part), 3/2015 (part) & 3/2020 (part).

After retirement, he had written several letters & reminders only to get verbal assurances that the matter will be resolved soon. (vide 4 pages in Annexures).

It is strange that, all through these past years, concerned Regional offices of CMPFO failed to reconcile the missing entries for the above 14 nos. of Financial years. Again, he is being victimized for no fault of his own as he was very loyal and sincere in his duties towards coal company and could not detect the discrepancies during his service career.

Under the circumstances, it is requested to constitute a Task force to rectify the errors and wind up the case at the earliest so that he is able to receive his PF dues and pension as well.

It further requested to initiate suitable disciplinary action against all concerned responsible for lapses on their part and causing pain and trauma to Sri Gupta in getting his dues.
