Sub: <u>Breach of Trust regarding withdrawal of Fast unto Death on 16th Aug. 2021 announced by Sri H. K. Chaudhury, and our subsequent meeting with you on 13-8-2021</u>

Dear Sir,

Kindly refer to your letter no. CPF/CP/111(26)/Pen/RAN-I/Vol-III/435 dated 11th August, 2021 addressed to our member, Sri H K Choudhury regarding re-fixation of pension as his actual date of appointment in CIL is 1-8-1973.

In response to the above-mentioned letter, Sri Chaudhuri reached Dhanbad and had a fruitful meeting in conducive atmosphere on 13-8-2021, in which officials from ECL and CCL also participated. It has also been informed that Dr B K Shrivastav participated on behalf of AIACE to assist Sri Choudhury in the meeting.

In this meeting, the dispute over his date of appointment was resolved to be as 1-8-1973 from the records produced by the concerned company officials.

However, the issue of his contribution @Rs 19 per month from 1-8-1973 could not be concluded in a definite way, and the then Commissioner of CMPFO proposed to seek approval of CMPF Trusty Board for deposit/collection of the said amount in a fresh manner since such similar cases were reported to be pending with CMPFO, all of whom will also get settled as per Board's fresh directions.

Accordingly, Sri H K Choudhary withdrew his decision to sit on fast unto death WEF 16/8/2021 in good faith and AIACE too communicated the decision to you vide letter no. AIACE/CENTRAL/2021/086 dt. 14-8-2021.

Now Sri H K Chaudhury has communicated his frustration that the matter still remains unresolved (vide Annexure-I).

We at AIACE feel that with change of guards at the top of CMPFO, the continuity is broken and no one bothers to pursue with the consensus arrived in the meeting dated 13-8-2021. This is highly deplorable.

As such, it is requested to resolve the issue of Sri H K Choudhary without further delay, along with all other such cases which are in the knowledge of CMPFO.
