Your kind attention on the above subject is requested to be drawn to our more than 3-year old letter vide ref no. AIACE/CENTRAL/16 dt. 1/2/2019. (Copy attached as Annexure I)

It is to state that, CIL-Executive Defined Contributory Pension Scheme, commonly known as NPS, effective from 1.1.2007, was implemented in the year 2019 and arrear settlement of all the working and retired executives were done. Corrections in calculation were also rectified in a timely member by all subsidiaries.

Strangely, our member Sri Nilkanth Sharma, EIS no. 90053315, retiring from BCCL's Govindpur area on 31/1/2012 has been denied rectification of errors by concerned authorities. His PF contributions are missing for month of September,2010 and March,2011 ( i.e for 2 months). (Annexure-II, III & IV)

Since last 3 to 4 years, he has been running from pillar to post for this rectification. As per his information, apparently his file is in the final stage at GM(Systems), awaiting data & clarification from AFM, Govindpur area.

It is regretted that, AFM, Govindpur area is failing in discharging his duties to settle the case.

Therefore, its requested to direct the concerned officer for sending required data to GM (System), Kolya Bhawan to avoid prolonged delay and harassment.

Last letter dt 07/08/2021 was written to AFM, Govindpur by Regd Post <sup>by me</sup> which was forwarded to GM (System) BCEL HQ (copy enclosed) by Govindpur area. The file is lying in EDP Section HQ awaiting some clarifications reqd from Govindpur area.

Therefore, it is requested to look into the matter and direct concerned official for early correction of data to avoid unnecessary harassment.

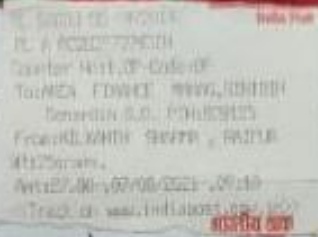

Earlier letter was also written to GIM (EE) K. Bhawan BCEL HQ and further advised to contact SSA On further scrutiny, it has been learnt that in V.V. statement of F.V 2010-11, P.F amount has been taken only for 06 months whereas salary payment of the undersigned has been started at Govindpur Area from August 2010 and total months should be 08 months in V.V. statement from August 2010 to March 2011.

As such, these two months P.F amount was not paid to the undersigned till date.
