Sub:- Request for releasing payments of Bills, pending under CPRMSE, in respect of Sri H. Sreekanthan, EIS No. 55000843

Dear Sir,

CMPDI is known for its credibility and transparency in settling CPRMSE claims for beneficiaries. However, probably due to recent change-over to SAP platform, some beneficiaries – specially the executives who were not allotted EIS No. during their service career – are facing difficulties in reimbursement of their claims under CPRMS.

In one of such cases, our member Sri H. Sreekanthan, EIS No. E55000843, has endorsed us a copy of the representation sent to GM (P/EE), HQ as attached in Annexure-I. His 3 Bills are pending for reimbursement as briefly described below:

1. OPD Bill for the period March,2021 to June,2021 for Rs 62,784/-
2. OPD Bill for the period July,2021 to October,2021 for Rs 42,164/- - submitted on 21-12-2021
3. OPD Bill for Rs 2,367/-

Out of the above 3 Bills, movement of only the first bill is known as described below and fate of remaining 2 Bills is unknown. Timeline for movement of the first Bill of Rs 62,784/- is:-

- a) on 20-10-2021, Dy. CMO raised query on empanelment of Hospital
- b) on 26-10-2021, Bill re-submitted with clarification which was approved by Dy. CMO and forwarded to Finance
- c) on 2-2-2022, the Bill returned by Finance.
- d) on 5-2-2022, the bill was sent to CFM

Looking into the movement of first Bill, it is apprehended that the remaining 2 bills are also subjected to unwanted movements between various sections/departments.

Under the circumstances, we request you to order probing the status/fates of all these above 3 bills and needful instructions to all concerned for earliest reimbursement to this gentleman in his eighties.
