Sub: Wrong fixation of Pension of Sri Prantick Choudhary and reluctance of CMPF Ranchi Region-2 Office to rectify it

Dear Sir,

It is to bring to your kind notice that our member Sri Prantick Choudhary, Retd Chief Manager (E&M), CMPF A/c No. JBP/34/3540 has intimated us that, vide PPO No. 1190001324 issued on 1.10.2021 his pension has been wrongly fixed at a lower amount of Rs 55704/- by CMPF, Ramgarh, Ranchi 2 office. (Annexure-I)

The Notional salary per month calculated by Mines Rescue station, Ramgarh, CCL, (employer in this case) is shown to be Rs 225063.20. (Annexure-II)

In a very simple calculation, 25% of this notional salary comes as 56265/- which should have been his ideal pensionable amount. Thus, per month he is receiving Rs 561/- lower than the actual.

To rectify this error, Sri Choudhary has run from to pillar to post in the concerned CMPF, Ramgarh, Ranchi 2 office, but all his efforts have failed to yield desired result.

Under the circumstances, it is requested for needful advice to Regional Commissioner, CMPFO, Ramgarh, Ranchi 2 office for speedy disposal of the case and live up to expectations of its subscribers.
