Dear Sir,

Your attention is requested to be drawn to the two letters issued by you, copies of which are enclosed in Annexures I & II.

Through these two letters dated 8<sup>th</sup> January 2021 and 17<sup>th</sup> December, 2021, you were kind enough to allow crediting of additional component of rate of interest payable to the CMPF subscribers for the years 2018-19, 2019-20 and 2020-21 after obtaining needful clearance of the government.

We have to inform you about non-implementation of these office orders for those subscribers who have superannuated after issuance of these orders. Through various interactions with you, we had been assured that appropriate modalities will be soon notified for crediting the arrears of Interest soon specially for these retirees who are loser by way of gaining less amount in PF settlement due to this variation in interest.

It is regretted that, in stead of sending copies of these office -orders to your Regional offices, you have preferred to send copies to CMDs of all the coal producing companies who have no role in shelling out any penny. We feel that you are simply fooling the affected subscribers;

Since the financial implication of this is quite considerable from the point of view of the retired executives, many such affected members of AIACE have represented to us to take up this issue with concerned authorities.

It is once again requested to direct regional offices to credit the additional interest amount to all the concerned beneficiary without further delay. If not done, the affected persons will be forced to sit on indefinite dharna and will take other actions for which CMPFO official will be solely responsible.
