Dear Sir,

It is to bring to your kind notice that our member Sri Anil Kumar, Retd GM(X), SECL Gevra Project, CMPF A/c No. SING/12/0486 has intimated us that, he retired on 31-8-2021 and his pension was fixed at Rs 58037 considering DA at the pre-revised old rate. (Annexure-I).

Subsequently, new revised DA with effect from 1<sup>st</sup> July, 2021 were notified which resulted in a recalculated marginally higher pensionable amount of Rs 58514 which was duly communicated to Regional Commissioner, CMPF, Bilaspur by the Project Office vide letter no. SECL/MP/Personnel/GevraProject/CMPF/2021/1221 dt 6-10-2021. (Annexures – II & III).

To get revised pension, Sri Vinay Kumar has run from pillar to post in the concerned CMPF, Bilaspur Regional Office, but all his efforts have failed to yield desired result.

Under the circumstances, it is requested for needful advice to Regional Commissioner, CMPFO, Bilaspur Regional Office for speedy disposal of the case and live up to expectations of its subscribers.
