
Dear Sir,

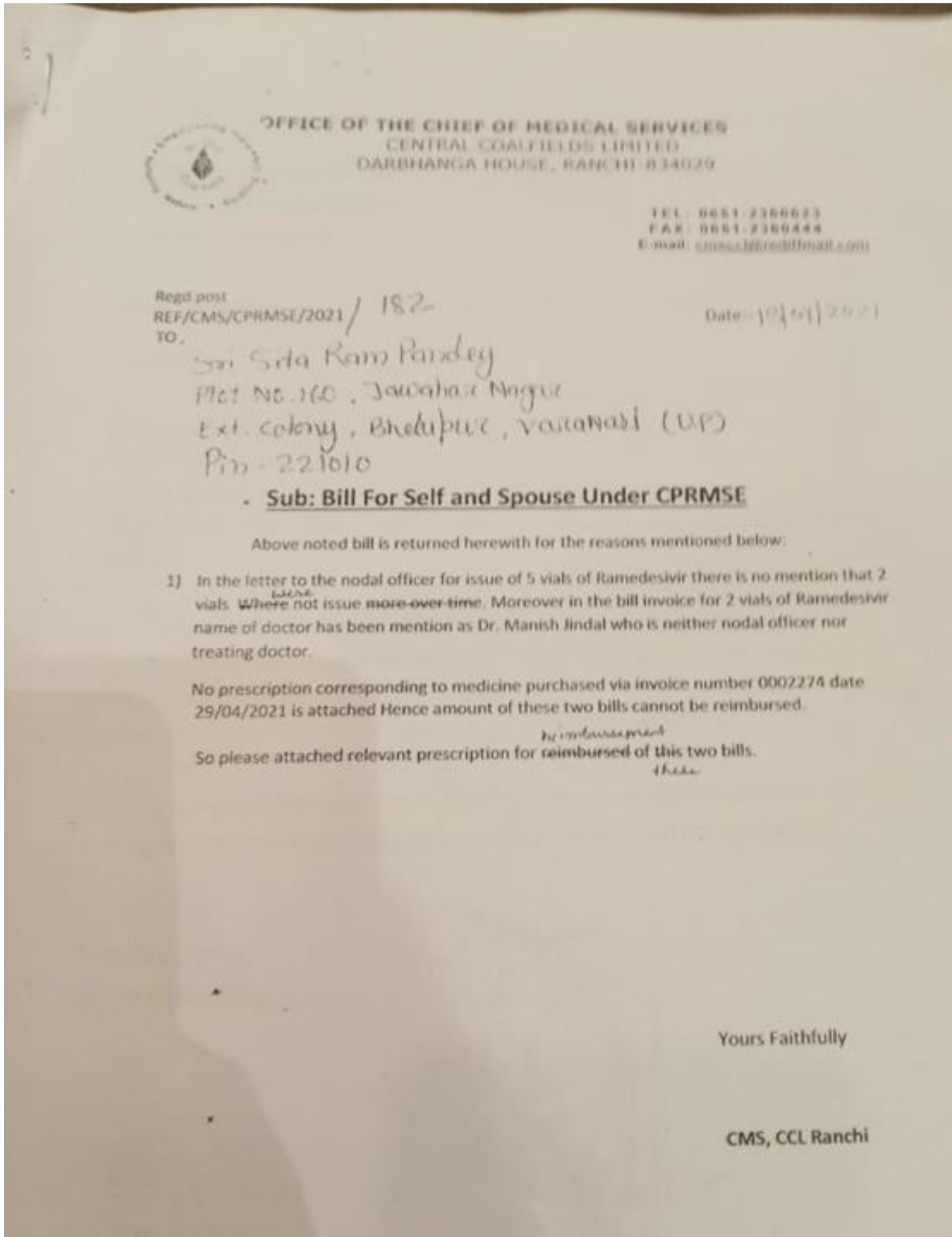


Dear Sir,

This letter is in reference to the clarification asked for the bill dated 17/4/2021, invoice number F0002564 for the procurement of 2 vials of inj. Remdesivir. As you know at that time there was a huge shortage of the above injection so it was procured via reference of Dr. Manish Jindal from the medical store of the hospital where Dr. Manish Jindal works. That's the reason his name is mentioned on the invoice.

And, in regards to the bill dated 29/4/2021, invoice number 0002274. Please make partial payment of it (except for the thermometer, oximeter and hand sanitizer) rest of the medicines were either mentioned on discharge card of Omega Plus Hospital or by Dr. Rajeev Kumar Gupta on the pre printed medicine paper that has been marked 'Not Authentic' by you. But the fact is at that time doctors were handing out such pre printed medicine papers along with their prescriptions.
