## Sub: Intimation of ongoing agitation by coal pensioners and the need to accelerate ongoing reforms as suggested by CAG & PAC

Dear Sir,

Your attention is drawn to copy of letter written by our sister organization AICPA (All India Coal Pensioners' Association), addressed to Hon'ble Prime Minister (Enclosure-I) with copies of receipt of letters delivered in the offices of Hon'ble PM, Hon'ble Home Minister and Coal Secy on 1<sup>st</sup> August, 2022. (Enclosures II, III and IV respectively)

The subject line of the referred letter is, **Compelling decision to stage Dharna from 25-7-2022 at Jantar-Mantar, New Delhi against non**review of CMPS-1998 and non-revision of pension and failure of Ministry of Coal and CMPFO in this respect causing stagnant pension for last 24 years in coal sector.

Feeling betrayed, agitated individual pensioners across the country had staged relay Dharna for 5 days from 25<sup>th</sup> July, 2022 seeking justice by drawing the attention of authorities towards the injustice being meted out to them. Their grievances are briefly described below.

Contributory Pension scheme for retirees in Coal sector, run by fund provided by equal contribution from employee and employer, suffers from Mismanagement of fund and poor design of scheme as pointed out and accepted by government in 36<sup>th</sup> Report of PAC NO. 2244 submitted to Parliament in 2021 by PAC for Ministry of Coal. Accordingly, some steps have been reportedly initiated for review and upward revision of pension which has never been done for past 24 years at regular interval of 3 years as stipulated in scheme.

In this regard, we are grateful to the Secretary, Coal, for facilitating our interaction with the Economic Adviser to the Ministry of Coal on 5<sup>th</sup> March 2021. As a result of the talks, vide letter no. AIACE/Central/2021/25 dated 11.3.2021, we had sent our proposals/suggestions, after which on 7<sup>th</sup> April, 2021, CMPF had invited comments from all Coal companies and BOT members. (Enclosure-V)

We are not aware of any further action on our suggestions, but, later on in an intelligent move, CMPF requested all coal companies to levy a voluntary cess of Rs 10 per tonne production of coal. This somewhat compensated for the erosion of fund. Proceedings of last meeting held in January, 2022 of CMPF Board of Trustees suggest that steps are underway to explore the feasibility of enhancing this cess and making it compulsory to arrive at a permanent all time long-run solution. However, the pensioners seek an accelerated effort and early time-bound commitment to overhaul the entire pension scheme and urge for allowing an ad hoc enhancement of pension till the scheme is overhauled.

It is a bitter truth that, poor pensioners are paying price of earlier misdeeds and their loss cannot be reclaimed by any means. To press for fulfilling these demands, the pensioners propose the next Dharna at Jantar Mantar on 5<sup>th</sup> December, 2022.

Under the circumstances, your kind initiative and interference are solicited for breaking the ice and activating the decision making process of Board of Trustees for needful action. We at AIACE are also ready to contribute by sharing our expertise.

Subject: Compelling decision to stage Dharna from 25-7-2022 at Jantar-Mantar, New Delhi against non-review of CMPS-1998 and non-revision of pension and failure of Ministry of Coal and CMPFO in this respect causing stagnant pension for last 24 years in coal sector.

Rrespected Sir,

It is to bring to your kind notice that, a contributory pension scheme called CMPS-1998 was introduced for retired employees in coal sector by BJP led NDA govt in 1998. It was made effective from 1<sup>st</sup> April, 1994. It was claimed as a revolutionary measure by the government for providing robust social security to coal employees and workers.

But, the retired employees of Coal India, Singareni Collieries Company Limited and some other private companies have been striving for the last several years to bring the problems being faced by them to the notice of the competent departments. In the past, members of our sister organization AIACE and AICPA, have been approaching government and CMPFO authorities for review and revision of pension. We have tried to convey our grievances to the Ministry of Coal through many parliamentarians, but due to not getting the expected success, we have turned towards you with great expectations to provide relief to old retired coal employees.

CMPS-1998 is being operated by the Coal Mines Provident Fund Organization (CMPFO) working under the Ministry of Coal. In this, the pension amount payable on retirement remains constant throughout the life. Due to various irregularities, it has not been amended for the last 24 years, although there is a provision to review and revise the pension payable in the pension scheme after every three years.

Sir, it is a matter of surprise that as of today many coal pensioners/their widows are getting less than Rs 500/ to Rs 1000/ as monthly pension, whereas, under govt schemes for older people the amount is more than this amount. It is pertinent to note that these old coal employees have put their mites in their youth to produce coal to meet the energy security of the country.

We want to bring to your kind notice that, the Public Accounts Committee dealing with the Ministry of Coal had placed its 12th Report on 'Fund Management' in both the Houses of parliament on 18th March, 2020 and the Committee submitted its report to both the Houses on 21st July, 2021 with the action taken thereon. But the fact is that, these recommendations on strengthening the pension fund in favour of pensioners with some reforms in fund management perhaps have not impressed the concerned ministry on pension revision and enhancement. The coal ministry is unclear and the lack of action on this issue is clearly visible.

It is also the fact that the individuals and departments responsible for the related errors remained untouched, but the common pensioners had to bear the brunt of it. Due to financial mismanagement and inherent faulty concepts of the scheme, the pension fund, created out of contribution by coal employees/workers, got depleted gradually.

It is a bitter truth that, due to the past decisions of the departments concerned and the present indecisions, the rhetoric of pension increase is taking lives of many elderly pensioners every year.

In the light if above facts, it is requested to constitute a high-power committee on the issue of review and revision under CMPS-1998 in which our representatives should also be included to submit our views. In this regard, our associate organisation, All India Association of Coal Executives (AIACE) had submitted some suggestions in March 2021 vide letter no. AIACE/CENTRAL/2021/25 dated 11.3.2021.

It is to reiterate that pension can be increased without any budgetary support from the central government and meeting the same from the coal production companies by levying a small amount on selling price on account of pension fund as being done by some of the electricity producing and distribution companies.

To draw kind attention of all concerned, for the revision and increase in the pension of the coal pensioners without further delay, under the banner of All India Coal pensioners Association (AICPA), the coal pensioners from all corners of the country, have decided to stage relay dharna, from 25<sup>th</sup> July, 2022 at Jantar-Mantar, New Delhi.

Finally, we do not want confrontation with the government, but at the same time we seek resolution of our issue.

With great expectations from the highest authority to take decision on the matter.

**Rrespected Sir**,

It is to bring to your kind notice that, a contributory pension scheme called CMPS-1998 was introduced for retired employees in coal sector by BJP led NDA govt in 1998. It was made effective from 1<sup>st</sup> April, 1994. It was claimed as a revolutionary measure by the government for providing robust social security to coal employees and workers.

But, the retired employees of Coal India, Singareni Collieries Company Limited and some other private companies have been striving for the last several years to bring the problems being faced by them to the notice of the competent departments. In the past, members of our sister organization AIACE and AICPA, have been approaching government and CMPFO authorities for review and revision of pension. We have tried to convey our grievances to the Ministry of Coal through many parliamentarians, but due to not getting the expected success, we have turned towards you with great expectations to provide relief to old retired coal employees.

CMPS-1998 is being operated by the Coal Mines Provident Fund Organization (CMPFO) working under the Ministry of Coal. In this, the pension amount payable on retirement remains constant throughout the life. Due to various irregularities, it has not been amended for the last 24 years, although there is a provision to review and revise the pension payable in the pension scheme after every three years.

Sir, it is a matter of surprise that as of today many coal pensioners/their widows are getting less than Rs 500/ to Rs 1000/ as monthly pension, whereas, under govt schemes for older people the amount is more than this amount. It is pertinent to note that these old coal employees have put their mites in their youth to produce coal to meet the energy security of the country.

We want to bring to your kind notice that, the Public Accounts Committee dealing with the Ministry of Coal had placed its 12th Report on 'Fund Management' in both the Houses of parliament on 18th March, 2020 and the Committee submitted its report to both the Houses on 21st July, 2021 with the action taken thereon. But the fact is that, these recommendations on strengthening the pension fund in favour of pensioners with some reforms in fund management perhaps have not impressed the concerned ministry on pension revision and enhancement. The coal ministry is unclear and the lack of action on this issue is clearly visible.

It is also the fact that the individuals and departments responsible for the related errors remained untouched, but the common pensioners had to bear the brunt of it. Due to financial mismanagement and inherent faulty concepts of the scheme, the pension fund, created out of contribution by coal employees/workers, got depleted gradually. It is a bitter truth that, due to the past decisions of the departments concerned and the present indecisions, the rhetoric of pension increase is taking lives of many elderly pensioners every year.
