Your attention is drawn to copy of letter written by Sri Anand Mohan Gupta, CMPF A/ No. DHN/40/1989 to Regional Commissioner, CMPF, Bilaspur on the above subject. (Annexure-I)

Sri Gupta has retired from the service on 31-12-2020 and his major grievance is about non-receipt of CMPF contribution amount for the following periods:-

- i. year ending 31/3/1991,
- ii. year ending 31/3/1992,
- iii. 5 months of year ending 31/3/1993,
- iv. 3 months of year ending 31/3/2009,
- v. part months of year ending 31/3/2013 and,
- vi. part months of year ending 31/3/2014.
- vii. Anomaly of contribution for the year ending 31/3/2021.

For correction of entries, Sri Gupta had been running from pillar to post but of no avail. Last time he visited the office of Regional Commissioner, CMPF, Bilaspur but no discussions could materialize as the dealing assistant was on leave.

Under the circumstances, the issues remain unresolved till now. It is strange that, the concerned office of CMPF is not taking any initiative and expects the sufferer to run after them every day.

As such, your kind intervention is requested to improve the work culture prevailing at the Office of Regional Commissioner, CMPF, Bilaspur and resolve the present issue at the earliest.
