Sub- Engaging executives in election duty of an unregistered entity CMOAI causing misuse of the company resources

Dear Sir,

It has been gathered that some of the subsidiary companies of CIL are extending undue and unlawful favours to an unregistered entity (CMOAI) which claims to represent executives of Coal India Ltd.

The management is also favouring this body by allowing membership fee deduction from salary of executives in an unauthorized manner without getting consent from them. You may be aware that every year workers' union submit the list of members and the management verifies the members regarding their willingness to pay subscription to which union. This deduction is illegal and needs to be revoked.

Now, this unregistered body is claiming to undertake a so called election to form its new bodies at various levels like Unit/Colliery/Area/Company etc after a very long time without following the stipulated periodicity of election. It is further learnt that executives are likely to be deputed in conducting the election process of this unregistered body. The election notification of CCL and NCL are enclosed herewith. (Annexure-I)

This election is nothing but a drama being conducted by an unregistered entity. As such, we strongly protest this engagement of executives which amounts to misuse of the company resources.

It may be recalled that, CMOAI is not at all a registered body, whereas, ALL INDIA ASSOCIATION OF COAL EXECUTIVES (AIACE) is the true association of serving and retired executives of CIL/SCCL and is registered under Trade Union Act, 1926 vide registration no. 546/2016 and is subjected to submission of annual report and financial audit report every year with Registrar of Trade union and also files Income tax return with Income Tax department.

The management may verify the status of CMOAI by asking its functionaries to submit annual reports of last 5 years submitted with designated Registrar of Trade union. Alternatively, the management can verify from the Registrar of Trade union of the state govt, where CMOAI claims to be registered and can verify also whether it is registered and live or not. The same reports have also been collected from us and annexed with this letter which confirms that ***"there is no registered trade union under the name and style of Coal Mines Officers' Association of India"***.

For allowing facility as cited above regarding engagement of executives in illegal election process and favour to an unregistered body, it is requested to initiate disciplinary action against officials who knowingly are doing illegal acts.




