Sub: Request to take strict action against assault of, on duty officer, Shri. Udesh Ram, Asst. Manager (Mining) by Authorised Middleman/Representative Shri. Suraj Kapur (M/s Surathgarh Thermal Power Station Company)

Respected Sir,

With reference to the above subject, it is to bring to your kind attention that yesterday (02/09/2022) evening around 1600 hours to 1630 hours Shri. Udesh Ram, Shift I/c has been assaulted by Authorised Middleman/Representative Shri. Suraj Kapur (M/s Surathgarh Thermal Power Station Company) while performing official duty. When Shri. Udesh Ram, Shift I/c came out of the mine Incline and went to enquire about bunker report where he saw 15 to 20 unauthorised persons over and around the coal bunker (Bhadra 7/8 Mine) who were cherry picking coal from stockyard and loading the vehicle and were repeatedly moving vehicle (Road Sale) to and fro for taking load from the bunker and throwing the coal back in coal stock yard and again taking load as per their whims. Thereafter, Shri. Udesh Ram, Shift I/c asked the Shri. Suraj Kapur and his associates to vacate the occupation of bunker but Shri. Suraj Kapur got down furiously using abusive language, threatened for life & limb and slapped Shri. Udesh Ram, Shift I/c in front of his shift subordinates. Shri. Suraj Kapur was under influence of alcohol at that time. After the incident the aggrieved executive, Shri. Udesh Ram, Shift I/c is under extreme fear for life and feeling humiliated. Copy of office communication no. 796 dated 02/09/2022 addressed to SHO(TI), Bhalumera enclosed along with copy of letter written by aggrieved to Manager, Bhadra 7/8 mine and Sub Area Manager, Bhadra Sub Area, Jamuna Kotma Area (Annexure A - 03 pages).

It is submitted to your kind self that it is almost impossible to work under such unconducive circumstances wherein we are assaulted, threatened for life & limb and not allowed to perform official duty to the best of our ability. Other incidents have also occurred in the area earlier due to these continuous happenings we are under extreme fear and stress.

It is requested to your kind self to take strict necessary action against the culprits so that we can perform our duties to the best of our abilities.
