Sub: Request for stoppage of illegal undue favours to an unregistered entity CMOAI and stoppage of check off facility extended to it

Dear Sir,

It has been gathered that ECL, a subsidiary company of CIL, is extending undue and unlawful favours to an unregistered entity (CMOAI) which claims to represent executives of Coal India Ltd.

The management is also favouring this body by allowing membership fee deduction from salary of executives in an unauthorized manner without getting consent from them. You may be aware that every year workers' union submit the list of members and the management verifies the members regarding their willingness to pay subscription to which union. This deduction is illegal and needs to be revoked.

In support of our statement please refer to the 3 annexures with this letter.

Annexure-I contains the 7 questions submitted under RTI seeking information from CPIO, CIL.

Annexure-II shows copy of the reply received for 5 of the above 7 questions received from CPIO, ECL.

Annexure-III shows copy of the remaining 2 replies received from CPIO, ECL. This reply clearly shows that,

- (i) there is not agreement between this so called Association and Management for check off by the company and,
- (ii) management does not collect individual consent from executives for such collection of subscription

Under the circumstances, it is requested for "Immediate Stoppage" of this illegal practice of collecting subscriptions for and remitting towards CMOAI.


