Dear Sir,

Our member, Sri Pramod Kumar, EIS No.-90128646, Sr. Manager(M), Hazaribag Area CCL, has intimated AIACE that, his promotion is pending from Aug. 2019, DPC, because of a fatal which occurred on date 03/04/2019 at Amera OCP, Bishrampur Area , SECL while he was manager of the mine.

After an enquiry, department already awarded him a minor penalty of "Censure" in 2019, vide letter no. -SECL/BSP/EE/R-31/07 Dated 31/12/2019 /02/01/2020 which is now more than two and half years since then. (Annexure-I)

On one of the earlier representation, it was clarified to him that he was not considered for promotion due to pending of a complain case(case no.1723 /19) in district court, Ambikapur, filed by DGMS , Raigarh Region. (Annexure-II)

A board note was put up on the board of SECL under the provision of circular no.-CIL/C5A(PC)/Safety clearance/753 dated-26/08/2021, but his case was not placed in the board because he was transferred from SECL to CCL.

Now, as already communicated to GM(S&R), it is more than a year since the said case has been disposed. (Annexure-III)

Therefore, it is requested to kindly direct the concerned official to issue safety clearance as earliest so that his promotion in E-7 grade, in first class channel in mining discipline, can be released from eligible date for which he will be highly obliged.
