Your kind attention is requested to be drawn to our letter no AIACE/CENTRAL/2022/17 dated 1<sup>st</sup> March 2022 regarding pending cases of revision of pension arising out of revision of pension with effect from 1-1-2017. (Annexure-I).

On this issue, we had been regularly writing to you for needful action from your end. In this connection in the last letter, 7<sup>th</sup> in the series, we had identified and referred 21 cases to you for re-fixation and enhancement of pension. In this letter, the case at Sl. No. 21, in the name of Sri Subhra Ghosh (EIS no. 90105172; CMPF no. CHW/21/126; PPO No, 220181901234) belonging to Nagpur Area of WCL is still pending.

We do not know, why an elderly person is still being harassed by the responsible persons involved in the process. This smells of foul play and corruption in the system and the guilty deserve to be punished by fixing the responsibilities.

Sub: Pending cases of re-fixation of pension due to Pay revision of executives with effect from 1-1-2017

Dear Sir,

Pursuant to the revision of pay scales of executives of Coal India Ltd. with effect from 1<sup>st</sup> January 2017, the pension amount payable to executives superannuated after that date under Coal Mines Pension Scheme, 1998 was to be enhanced according to the new pay scales. However many executives, who retired after 1-1-2017 but before implementation of the revised pay scales, continue to receive pension at the old rates. In this connection we had sent you the details of such executives as per our letters referred to below.

This inordinate delay is causing anguish and concern to the retired officers. We request you to kindly look into the matter and settle the cases at the earliest to avoid any compensatory claims by the affected persons.
