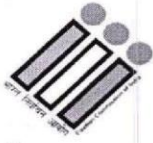

Dear Sir,

We are aware that in our democratic nation, Election Commission of India (ECI) is entrusted with a vital job of conducting elections to various constitutional bodies like Lok Sabha, Vidhansabha, Municipal & Panchayat bodies etc.

To fulfil its mammoth requirement of manpower for such elections, ECI draws required manpower from Institutions, or Undertakings which are established under Central/State Act or which are controlled/financed wholly/substantially by funds provided directly/indirectly by Central/State Govt.

It has been learnt that list of executives working in South Eastern Coalfields Ltd (Coal India), has been requisitioned for engaging in election duty for Legislative Assembly election in Chhattisgarh and Madhya Pradesh in 2023.
