Sub: Inability of CIL to prevent CMPDIL framing its own Rules

Dear Sir,

On 15th January, 2024 in a meeting held with you at CIL,HQ, out of several other issues, it was brought to your kind notice that, CMPDIL is working in its own way in interpreting the rules under CPRMSE.

The matter of Finance Deptt. Of CMPDIL framing their own rules and harassing retired executives by way of refusing copy of New Format Medical Card (ATM card like), and instead, asking for copy of OLD Medical Card from executives to process Claim of Bills under CPRMSE. Proper actions in this regard were assured to us on submission of documentary evidence, which were duly submitted next day vide letter no. AIACE/CENTRAL/2024 dt. 16-1-2024. (Copy attached vide CASE-I, Annexure -I)

We are not certain whether any directive has been issued or not in this regard, in another bizarre incident, in violation of Office Order No: CIL/C5C/55125/2021/2081 dated 05-07-2021 issued by Dy. GM(P/Welfare), CIL; Digital Life Certificates for CPRMSE as implemented for CIL & Subsidiaries are being refused by CMPDIL and reimbursements are withheld causing unwanted harassment to executives. Documentary evidences for a case of one retiree Sri. A Ravishankar are attached herewith where he has been asked to resubmit the Life Certificates in OLD Physical format. (Copy attached vide CASE-II, Annexures-I, II & III)

Under the circumstances, it is requested that CIL should exercise its power to restrict CMPDIL and other subsidiaries to refrain themselves from floating their own rules & regulations and honour the centralised directives of CIL.

Dear Sir,

It is brought to your kind notice that, CMPDIL is working in its own way in interpreting the rules under CPRMSE.

We do hereby submit the documents showing how Finance Deptt. Of CMPDIL has framed their own rules and harassing retired executives by way of refusing copy of New Format Medical Card (ATM card like), and instead, asking for copy of OLD Medical Card from executives to process Claim of Bills under CPRMSE.

In one such case, our member Dr B. K. Shrivastav, EIS No. 90015652, had brought the matter to our notice after which we had written about it to CMD, CMPDIL on 5-12-2023 which remained unanswered till now. (vide Annexure-I)

Even Dr Shrivastav wrote individually to Grievance cell, who on 6th January, 2023 informed that, the matter has been enquired from finance deptt, which informed ***"As per extant rules & guidelines of the company regarding CPRSME, the inclusion of copy of old CPRSME Card is necessary to be enclosed along with the bills."*** (vide Annexure – II)

Under the circumstances, it is requested that CMPDIL and other subsidiaries be instructed to accept OLD, as well as, New ATM card-like copy of Medical card as is being practiced at CIL,HQ and stop framing their own rules.
