Mr. Biswas has been wrongly paid Rs. 12,000/- towards interest of NPS for the period from 01/01/2007 to 30/06/2009 instead of actual amount of more than two lakh rupees for the same.

CCL Authority has reportedly forwarded his case to CIL HQ, Kolkata and it is lying pending in the Finance Department of CIL HQ, Kolkata.

Under the circumstances, it is requested that the concern ed officials of CIL and CCL be directed to resolve the issue and release payment of interest component accrued till date to Sri Biswas.

It is further requested to resolve other such issues if lying either at CIL or subsidiary level without further delay.
