Sub: Submission of Widow pension claims at the Bank level without visiting place of last posting of expired pensioner

Dear Sir,

Your kind attention is requested to be drawn to your letter no. CPF/CP/111(26)/Pen/Misc/HQ/Part/284 dated 10.07.2024 on the subject "Submission of spouse claims under CMPS,1998 – reg".

It is to recall that there are 2 types of formats of PPOs (Pension Payment Orders) in use by CMPFO as below:

- i. Old Format for pensioners retiring prior to 1st September, 2023
- ii. New Format for pensioners retiring after 1st September, 2023

The new format is intended for easy starting widow/widower pension at the bank level itself i.e. from the respective pension paying bank branch from where the deceased pensioner was drawing pension. Needless to mention that your office is working hard towards Issuing new type Revised PPOs to all pensioners retiring prior to 1-9-2024.

Clearly your office order is related to the pensioners holding old type of PPO and is intended to ensure that the excess drawn pension is directly deposited in the main account of SBI, Dhanbad to avoid mismatch.

Your above referred letter has unnecessarily created panic among pensioners holding new type Revised PPOs who were assured of easy starting of widow/widower pension in case of unfortunate demise.

As such, it is requested that any subsequent order be properly issued by considering these 2 types of PPOs. It is further requested that a fresh S.O.P. for starting widow pension for pensioners holding new type of Revised PPOs may kindly be issued.

Sir,

CMPFO is in the process of issuance of Revised PPO for hassle-free payment of pension to spouse in the event of death of the pensioner. The claims of spouse for family pension is being submitted to CMPFO as per prevalent procedure.

- 2. It has been observed that due to delayed death intimation of pensioner to Payee/ Disbursing bank, payment of pension continues in the account of the pensioner. Consequently, there occurs delay in settlement of family pension claim, till recovery of excess credited pension.
- 3. It is, therefore felt necessary that in all future claim of family pension, a certificate in the enclosed Performa from the payee bank be submitted invariably with the spouse pension claim. Submission of above mentioned certificate in claim submitted earlier to CMPFO will facilitate quicker settlement of claim.

It is, therefore requested that concerned offices/ officials under your jurisdiction may be suitably instructed for submission of above certificate.
