Sub: Rectification of error causing abrupt disruption of payment against 2nd Annuity purchased under CILEDPCS vide Master Policy no. 402018199

Dear Sir,

Coal India Ltd has implemented a CIL Executive Defined Contributory Pension Scheme-2007 under which it has purchased a Master Policy no. 402018199 for its executives.

Accordingly, executives of CIL after retirement are receiving pension against annuity purchased on their behalf by CIL. Due to late implementation of the announced scheme CILEDPCS-2007, the executives retiring earlier have availed benefits of 2 nos. of Annuity for (i) Principal amount & (ii) Interest Amount.

We present below TWO (2) cases, where the surviving widows, who are our members, are being harassed by way of discontinuing the payment being made against 2nd annuity in respect of their late husbands.

Case-I for EIS No. 90064106

Sri Ramendra Nath Kar (EIS No. 90064106) retired from ECL Headquarters on 30/11/2013 and he has died on 24/04/2021.

Payment against First annuity 402200008687 of Late RN Kar is continuing to his widow Mrs Dipali Kar (AIACE ID no. 20087).

Payment for Second annuity vide 402200039697 started from 01/04/2022 and continued till 01/07/2023. Then stopped abruptly without stating reasons whatsoever.

Case-II for EIS No. 90026865

Sri Indra Nath Layek, (EIS No. 90026865) retired from ECL Headquarters on 30/09/2017 and he has died on 14/10/2020.

Payment against First annuity 402200006316 of Late Layek started after submission of Death certificate and is continuing to his widow Mrs. Rina Layek (AIACE ID no. 20084).

Payment for Second annuity vide 402200038795 started automatically and continued till 01/02/2024. Then stopped abruptly without stating reasons whatsoever.

We shall be thankful to you for enlightening us as to, for these 2 beneficiaries, why their 2nd pension against annuity purchased towards Interest portion has been stopped and when these payments will resume along with arrear payment with interest?
