Dear Sir,

Our member Late Subhash Kumar Rajgadia, EIS no. 90060575, had superannuated on 31-3-2015 as Chief Manager (Excavation) from NCL, Dudhichua Project. He was a pensioner vide PPO no. 22515160083.

After his retirement, he expired on 12th January 2024 due to cardiac arrest. After his death, his widow spouse Mrs. Aruna Devi Rajgadia submitted to Dudhichua Project, all the necessary documents for initiating her widow pension but still now it is not yet processed. The last of the required documents, viz. Banker's certificate confirming recovery of excess payment was generated and obtained on 14-8-2024.

During submission of her Widow Pension claim, CMPS-1998 was in transition period of switching over from old SAHAJ form to New SAHAJ Form. Bewildered as she was, she submitted New SAHAJ with needful attachments (Appendix-I), along with attaching all the other documents as required under old SAHAJ (Appendix-II).

Needless to say, Appendix-I contain copies of all the following required documents viz.,

- i. New SAHAJ form (Front & Back) – 2 Pages
- ii. Death Certificate – 3 Pages (Issued by different authorities)
- iii. Affidavit – 2 Pages
- iv. Copy of Spouse Aadhar card – 1 Page
- v. Copy of Spouse PAN card – 1 Page
- vi. Copy of Bank Pass book (Front & Back) – 1 Page
- vii. Bank certificates confirming Recovery of Excess Paid Pension – 2 Pages
- viii. Copy of PPO – 1 Page

It is regretted that, in spite of submitting so many documents, (Claim form in original), by widow of Late Rajgadia is being harassed by not processing the claim by Dudhichua Project. The veracity of documents for pension claim can be very well undertaken by authorities who have access to every documents. Late Rajgadia deserves a suitable tribute for his contribution to the company. If required, culprits may be identified for needful actions.
