Sub: Confirmation solicited on New method of processing Widow pension claims at the Bank level without visiting place of last posting of expired pensioner

Dear Sir,

It is to recall that there are 2 types of formats of PPOs (Pension Payment Orders) in use by CMPFO as below:

- i. New Format PPO for pensioners retiring after 1st September, 2023
- ii. Old Format PPO for pensioners retiring prior to 1st September, 2023 which is being gradually replaced by New Format PPO also called RPPO

The new format is intended for easy starting widow/widower pension at the bank level itself i.e. from the respective pension paying bank branch from where the deceased pensioner was drawing pension.

We had been repeatedly asking for proper Notification for announcing SOP (Standard Operating Procedure) to be followed for Widow Pension Claim settlements where the deceased pensioner has in possession of RPPO. Our request to various stakeholders went unheeded, but it is understood that a SOP has been placed in order as perceived while preparing Widow Pension Claim of our member late Swapan Kumar Datta (AIACE Membership No. M-1100) of Asansol Branch, who expired on 21/08/2024.

Referring to the Email correspondence in **Enclosure-I**, Sri Manish Shrivastava, Manager, State Bank of India 00066, CMPF Pension Cell, Dhanbad advised Mrs Basari Datta, the widower to submit claim in Annexure-K (**as in Enclosure-II**) along with other documents for starting the Pension at Bank Level.

This procedure of submitting claim in Annexure-K happens to be an entirely new process and has never been properly notified anywhere. Hence, on 27-1-2025, our AIACE Vice-President (Central) Dr B K Shrivastav had a telephonic discussion with Sri Manish Shrivastava, Manager, State Bank of India 00066, CMPF Pension Cell, Dhanbad enquiring the matter. During talks, Sri Manish Shrivastava confirmed about Annexure-K but, expressed his inability to produce any such Notification. It appears that this new process has been implemented via backdoor and very few persons, if at all, are aware of this.

Confirmation of this New procedure is requested from your end along with proper Notification for general awareness.
