The retired employees of Coal India Ltd. and its subsidiaries are required to submit a Life Certificate every year in November/December to avail all types of medical benefits, including fixed amount for Outdoor/Domiciliary Treatment under CPRMSE. As per letter No. Ref No: CIL/C-5C/55125/2021/2081 dated 05-07-2021 issued by Dy. GM(P/Welfare), CIL, the beneficiaries have the option to submit the Life Certificate in hard copy of revised format or generate Digital Life Certificate (Jeevan Pramaan).

So far, we have not faced any issue regarding continuation of medical benefits for beneficiaries drawing benefits from CIL, HQ where they continue to submit digital life certificates. However, the same cannot be said in respect of beneficiaries availing medical benefits from subsidiaries. Innocent beneficiaries are still awaiting release of their respective reimbursement of Domiciliary payment, **totally unaware of the fact that their Life Certificates submitted in Online mode have been dishonoured by the subsidiaries.**

We request you to establish a truly functional digital cell for processing/forwarding digital life certificates to every subsidiary, along with, instructions to all the Subsidiaries to immediately release payments to these beneficiaries awaiting payment with a request to establish a truly functional digital cell for processing/forwarding digital life certificates to every subsidiary.

Dear Sir,

The retired employees of Coal India Ltd. and its subsidiaries are required to submit a Life Certificate every year in November/December to avail all types of medical benefits, including fixed amount for Outdoor/Domiciliary Treatment under CPRMSE. As per letter No. Ref No: CIL/C-5C/55125/2021/2081 dated 05-07-2021 issued by Dy. GM(P/Welfare), CIL, the beneficiaries have the option to submit the Life Certificate in hard copy of revised format or generate Digital Life Certificate (Jeevan Pramaan). (vide Annexure-I).

So far, we have not faced any issue regarding continuation of medical benefits for beneficiaries drawing benefits from CIL, HQ where they continue to submit digital life certificates.. However, the same cannot be said in respect of beneficiaries availing medical benefits from subsidiaries. All subsidiaries are violating the instructions of CIL and have floated their own rules and, ignoring the digital mode, are insisting for hard copies. Almost every subsidiary, asks for Hard copies of Life certificate in Physical format and have made mockery of CIL's circular. Even, CIL has probably failed to ensure that its directives are being disregarded by subsidiaries.

Asking hard copy of Life Certificate in spite of the fact that they have the option to submit DLC electronically, is a retrogrative step by the Subsidiaries and is causing hardship to the retired employees.

We request you to establish a truly functional digital cell for processing/forwarding digital life certificates to every subsidiary, along with, instructions to all the Subsidiaries to accept Digital Life Certificate (Jeevan Pramaan) for the purpose of CPRMSE to alleviate the hardship to retired employees.

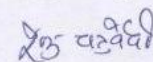
