Sub:- Strict action solicited against officers and officials disobeying the order and policies issued and implemented by Coal India Ltd.

Dear Sir,

Coal India Ltd in its capacity of Holding company, is responsible for implementation of uniform Rules & Regulations across the subsidiaries. But, it is pity that CIL has failed to ensure that its enacted rules & regulations are obeyed everywhere in all subsidiaries.

There are instances where employees, retired employees and general public in large have to suffer a lot due to irresponsible behaviour of officials posted in subsidiary companies. Such behavior tarnishes the image of CIL. The officials sitting in subsidiary level offices disregard centralized uniform rules of Coal India Ltd and frame their own.

It is informed that CPRMSE and CPRMSNE ie Contributory Post Retirement Medicare Scheme for Executives and non- executives have been implemented by CIL to be honored in it's offices & subsidiary companies. The initial notification for adoption and implementation of CPRMSE was done in 2012 with following 3 provisions for claiming reimbursement of treatment under it -

- 1) Form B1 for claiming Half-yearly reimbursement of Domiciliary treatment. This was later withdrawn and annual reimbursement was introduced on submission of Life certificate(s) of beneficiaries
- 2) Forms B2 and B3 for Bill(s) submission to claim reimbursement for Outdoor and Indoor treatment. For simplicity, in the year 2023, these 2 forms were merged into one single form and is well notified in the website of CIL at https://d3u7ubx0okog7j.cloudfront.net/documents/CLAIM_FORM_NEW-F.pdf.

Curiously, reimbursement claim in this combined single form is not accepted by all subsidiaries. Some subsidiaries like CCL accept claims in both the OLD and NEW form. But, the subsidiary like CMPDIL is adamant and deliberately refuses claims in NEW form. More details of a specific claim are shown in the letter issued by CMPDIL to one of the beneficiaries, late N. Mohan Kumar, EIS No. 90098880 who left for heavenly abode leaving behind 10 nos. of unpaid bills of around 6 lakhs. (Annexure-I).

Yet, for the reasons best known to Dr Shilpi, CMS-I/c, CMPDI, in 2nd week of May, 2025, the bills were returned asking for submission in OLD forms as shown in Annexure-I.

We are pained to elaborate above incident as **our past several requests to CIL, to have uniform rules implemented across the subsidiaries, have fallen on deaf ears.**

Under the circumstances, it is requested to issue needful instructions to CIL to exercise its authority to take appropriate disciplinary action against erring officials so that they will not dare to violate centralized rules framed by CIL.
