Sub: Phase-2 List for Issue of correct Revised Pension Payment Order (PPO) to every eligible pensioner

Dear Sir,

As per the decision of the Board of Trustees, CMPFO, Revised Pension Payment Orders were to be issued to Pensioners under CMPS, 1998. The Revised PPOs (RPPOs) were to incorporate the details of the pensioner's spouse to facilitate continuation of pension to the spouse on the death of the pensioner.

In the first phase, we had submitted a list of 387 pensioners, in 2 parts. Part-A consists of pensioners who have not received Revised PPOs and Part-B contains pensioners who have received erroneous RPPOs.

In the second phase, we are submitting hereby, a combined list of 91 pensioners, who have either (i) not received Revised PPO or, (ii) have received erroneous Revised PPOs. These pensioners belong to our twin Associations All India Association of Coal Executives (AIACE) and All India Coal Pensioners' Association (AICPA)

It is regretted that Revised PPOs have not been issued to most of the pensioners, in spite of the fact that, all the information required are already available with CMPFO and Pension Paying Banks. It is to inform that RPPOs issued to most of the beneficiaries contain some glaring mistakes thereby defeating the very purpose of this exercise. The nature of errors in revised PPOs clearly shows CMPFO's apathy and unwillingness to complete the work with perfection. This is also due to corruption prevailing among dealing personnels associated with the work.

Considering the hardships caused to the pensioners' families due to such delay/errors, it is requested to kindly expedite the issue of Revised PPOs on a war-footing in a time bound manner.

It is also requested to convene a meeting at the earliest with representatives of All India Association of Coal Executives (AIACE) and All India Coal Pensioners Association (AICPA) to present the case and extend any help, if required by CMPFO.
