- 3.Implementation of NPS wef 2007 and payment of interest.
- 4. Proper succession planning for board level posts in CIL and its subsidiaries for meeting successive targets set by coal ministry.
- 5. Creation of sufficient nos of post Executive Directors (E9 grade) below board level as per Maharatna Status of CIL.
- 6. Others.

The memorandum to be submitted to Chairman, CIL will include following issues.
