**I) Worked from 23/10/1963 to 07/11/1969 as overman.**

**II). Worked from 08/11/1969 to 14/03/1975 as overman at Sudamdih and**

**III). Worked from 15/03/1975 to 31/12/1995 at Sudamdih in E2 to E5 grade.**

**IV). Worked as Training Officer (E5) at Sudamdih Area w.e.f. 01/01/1996 to**

**31/03/1997.**

**After retirement, he applied for Pension after the merger of CCL SPF with CMPF as per Central Govt. Gazette Notification No:- G.S.R.107 (E) , Dated the:- 13.02.2003., from the Ministry Of Coal , Govt. of India, New Delhi.**

**He applied for Pension to the Personnel Manager, Bhowra Area on 28. 04. 2003 and submitted the application in Form PS – 6, along with the following documents:-**

- (a) Photographs of Self, Wife & Son. And photo copy of Bank Passbook.**
- (b) Copy of notice for Retirement on Superannuation.**
- (c) Copy of Pay slips for 12 months back, from the date of retirement.**
- (d) Copies of Certificates from the Adl. G.M. Sudamdih, BCCL, for Gratuity etc.**

**He submitted separate application in separate forms to the Sr. Personnel Officer (Nodal Officer), Pension Cell, E.J. Area, Bhowra on 30.04.2003 along with the following Forms, (properly filled up):-**

- (d) Form PS -3, ----- 4 copies.**
- (e) Form PS – 4, ----- 4 copies.**

- (g) Retirement Notice, ----- 1 copy.**

**Sri Ghosh could not follow up the issue in anticipation that he will be informed regarding further formality if needed for sanction of pension.**

**It is submitted that other executives retiring before 1997 are getting pension viz Mr. S. Chakraborti, - E5 and Mr. D.N. Moitra, - E6, of Sudamdih who retired in 1996.**

**It is requested to take needful action so that pension is started to Sri Ghosh even after 20 years of his retirement. It is submitted that Sri Ghosh is an honourable member of All India Association of Coal**
