All India Association of Coal Executives (AIACE) is an association of serving and retired executives of CIL and SCCL and registered under The Trade union Act 1926. It has membership from E1 level working executives to board level retired executives. Its membership is scattered all across India right from Assam in North East to Kerala in south.

We want to bring to your kind notice that some of genuine issues of executives have not been resolved like Maharatna pay scale, restoration of Coalfield allowance, enhancement of pension to old retirees, post retirement medical facility and implementation of NPS(CIL defined contribution pension scheme), creation of E9 grade in CIL and others.

It is also brought to your kind notice that under CMPS 1998, the executives /employees who retired before 1997 and 2007 are getting a meagre pension and it is very difficult to manage their life. You may be surprised to know that even CMDs/Directors who retired between 1994-2000 are getting a monthly pension between Rs 2000-5000, what to say about lower level executives and employees. Also, those who retired before 1/4/1994 are not covered under CMPS 1998, although their numbers is very small. In all, about 4.5 lakh coal executives/employees are affected directly under CMPS 1998 and indirectly, taking their sons/daughters and other relatives in count, total 10 million people are affected which is a very sizable number in comparison to total population of our country. These 10 million people will remain grateful for consideration of demand for enhancement of pension of their relatives who have worked hard in their life to produce coal and whose labour in the past has enabled CIL/SCCL to produce coal as per expectation of our PM for meeting energy need and lighting all houses of the country.

The representative of AIACE including ex chairman, CMD, directors of CIL/SCCL wish to meet you personally in Delhi to apprise the issues concerning all executives and employees of CIL/SCCL.

We request you to spare some of your valuable time from your busy schedule to meet us so that we may put our issues before you.

We shall be obliged, if we are given time to meet you either on 22nd or 23rd February,2019 or any convenient date.
