Sub:-- Special approval of treatment under CPRMSE for the wife of Sri K. C. Jerath, EIS no. 171199

Dear Sir,

Contributory Post Retirement Medicare Scheme for Executives of CIL and its subsidiaries (CPRMSE) was notified by letter no. CIL/C-5A (PC) / CPRMSE/2005 Dated: 28.12.2012. Over the past 6 years, this scheme has largely benefitted the executives. Executives are greatly benefitted by the provisions under this scheme. This scheme allows reimbursement of cost of treatment at hospitals empanelled with CIL and also at other hospitals empanelled with other Public Sector Undertakings subject to provisions under Clause 3.2.1 (a). (i). For clarity the rule is reproduced below:

Clause 3.2.1(a)(i) : Where there is no CIL empaneled Hospital at places where the retired executives reside/unable to go to such empanelled hospitals/Diagnostic Centres, the retired Executives can avail the medical facilities from other PSU hospital/ other PSUs empanelled Hospital, ESI Hospital, Government hospital including hospital under Municipal Corporation or Hospital/Diagnostic Centres empanelled by CGHS subject to CGHS rates for the items covered under CGHS and referred by Company Doctor or other extant guidelines and claim reimbursement of expenses incurred.

The underlined portion of the above clause allows treatment in non-empanelled hospitals in cases where the retired executive is unable to go from his place of residence. In one such case, our retired member Sri K. C. Jerath, EIS no. 171199, aged above 80 years, residing in BG-1/175, Pashchim Vihar, New Delhi-110063, was compelled to undergo treatment for her wife Mrs Shashi Jerath at Apollo Hospital, New Delhi, which is in proximity to his place of residence. Ironically, for reasons best known to CIL authorities, this hospital is empanelled with CIL for treatment of certain diseases and not for all diseases including the disease for which his wife is availing treatment there. It is a funny situation given the fact that this hospital is a well established reputed hospital and is empanelled for TOTAL treatments by various PSUs.

Under the circumstances, it is requested that Sri Jerath be allowed to take benefits of this clause and be allowed for reimbursement of all cost of treatments taken in the past, present and future at Apollo Hospital, New Delhi. As per his representation to us, his 2 medical bills for reimbursement are lying unpaid at NCL, HQ and no communication is being received by him.

Under the above stated circumstances, it is requested to accord him a permanent favourable approval of treatment at Apollo Hospital, New Delhi and advise authorities at NCL,HQ to release his reimbursement. A copy of approval may also be forwarded to all concerned in the matter.
