Sub:- Failure of Area Finance Manager, Bankola Area, ECL to comply with the letter written by Asst Commissioner of Income Tax, Circle-I, Asansol in the case of Sri Ashok Kumar Kinwar, Employee No. 19051300, Retd. Dy. C.P.M., Bankola Area, ECL

Dear Sir,

I take opportunity to put the case of one of our Advisory members, Sri Ashok Kumar Kinwar, Employee No. 190513/00, Retd. Dy. C.P.M., Bankola Area, ECL who superannuated on 31 December 2014 from SECL Bilaspur.

On a fateful day, on his Income Tax log-in page ,he found a Tax demand of Rs 74979 for the AY 2008-09 ignoring the fact that a TDS of Rs 89839 was deducted by Bankola area Finance authorities and even he had paid a self assesement tax of Rs 276. (See Annexure-I)

Mr Kinwar immediately wrote to the Income Tax Deptt on 7.12.2015 to rectify the error and resolve his problem. Accordingly, after scrutiny, Asst Commissioner of Income Tax, Circle-I, Asansol wrote to Finance Manager, Bankola Area, ECL on 10.12.2015 vide letter no. ACIT/Cir-I/ASL/TDS Mismatch/2015-16/352-54 dt. 10.12.2015, asking them to submit a TDS correction statement with NSDL for the AY 2008-09 and AY 2010-11. (See Annexure-II).

It is regretted that even after second representation to Income Tax deptt. on 29.2.2016, the Area Finance Manager of Bankola area has failed to comply with the desire of Income Tax authorities, and it is apprehended that this failure may attract penal actions on all those involved.

Apparently this mismatch has occurred due to the fact that at the given point of time, there was no provision to mention PAN number of employee in the Payslip. His PAN number is AEMPK3178B and with Employee No. 190513/00 as shown in the pay slip issued to him.

Sri Kinwar has settled in Bhagalpur after his retirement and is a senior citizen of 65 years of age. It is really a pitiable situation for him to run from pillar to post for the needful corrections required in order to have the records corrected.

This compels us to request you for your kind intervention and issuance of needful directives to the concerned officials so that Sri Kinwar may obtain an early resolution to his problems.
